These efforts include school leadership initiatives intended to inform and engage the community around the critical issues facing public education, CMS Board of Education Election Awareness, Community Conversations which provides platforms for citizens to weigh in on local, timely education matters; honoring CMS teachers for their leadership and mastery of best practices in the classroom; and a bi-weekly Enewsletter with local, state and national education news as well as an editorial section.

Career Pathways: Creating a coherent pipeline from K-12 to post-secondary education to help students access relevant pathways toward 21st century career opportunities. MeckEd currently has four FTE's in four different CMS high schools who serve hundreds of students with numerous workplace learning opportunities at various organizations and businesses.

Stemersion Program: STEMersion is a two week, summer professional development program for CMS Math, Science and CTE teachers and provides them with real-world experiences in companies that require significant math and science skills from their employees. MeckEd serves as the 501(c)3 organization that accepts all donations from those companies who participate in STEMersion. Once all the donations are tallied, the total revenue is divided among the number of teachers who participate. MeckEd receives no funding for this work and chooses to provide this volunteer service as a gift in kind to the STEMersion program.
