free entertainment, food and visits to temples.
- Started clean water program for rural towns in India. We matched people who
donated money to build and run water filtration plant to provide clean water to
whole town. So far we have 30 towns enjoying drinking clean water. Clean water has
affected people's health. Those towns had high rate of water born deceases due to
polluted drinking water.
- Launched anemia project in India. We tested and treated free of charge more than
20,000 women and children for iron differences due to poor nutrition and
intestinal deceases. Volunteer doctors from India now monitor these patients and
their progress. Due to this now thousands of people are enjoying more energy and
better health.
- Started sanitation program in 4 rural towns in India by providing toilets
facilities to homes who can't afford it.
