BEGINNING OPERATIONS IN 2000, THE COMMUNITY FOUNDATION OF BURKE COUNTY IS A NONPROFIT, TAX-EXEMPT ORGANIZATION AND RECEIVES GIFTS, ENDOWMENTS AND BEQUESTS FROM INDIVIDUALS, FAMILIES, BUSINESSES AND ORGANIZATIONS. THE ORGANIZATION USES DISTRIBUTIONS FROM THESE FUNDS TO MAKE GRANTS TO QUALIFIED CHARITABLE AGENCIES AND INSTITUTIONS PRIMARILY SERVING THE RESIDENTS OF BURKE COUNTY, NORTH CAROLINA.

SINCE THE PRIOR YEAR, THE FOUNDATION'S TOTAL ASSETS HAVE INCREASED \$2.9 MILLION, AND IT ADDED THREE ADDITIONAL ENDOWMENT FUNDS. THE FOUNDATION INCREASED ITS GRANT DISTRIBUTIONS IN 2013 BY OVER 5% OVER THE PRIOR YEAR.
