Harbour Pointe Montessori Early Learning Center provides a high quality educational program, classroom environment and teaching staff. We focus on emotional growth, intellectual development, social growth, physical development and spiritual awareness. The curriculum at Harbour Pointe Montessori Early Learning Center is a multi-faceted approach to Early Intervention services. Our unique program incorporates both the Montessori philosophy of education in conjunction with various techniques commonly used in many early childhood special education classrooms. We introduce and reinforce values such as being compassionate and kind, honest and responsible, and independent while also being aware of the needs of others. Our work with the children's social skills includes verbalizing their needs, problem solving and conflict resolution.

Sign Language is taught to all children as a means of communication, especially for our toddlers who are learning language. We often use additional visual aides as another form of communication. Our curriculum also offers weekly specialists. The music teachers work on rhythm and movement, introduction of instruments and fostering a love of music. Our Art teacher does an Art of the Masters program introducing children to famous artists and their artwork, then working with different mediums, textures and techniques. Our foreign language specialists include Spanish and Japanese. The materials in the school are designed with children's specific development in mind. We individualize our teaching strategies and techniques to further each child's individual growth and development.

Early intervention and inclusion for children with special needs is one of our priorities. We often enroll children who are on the Autistic spectrum. When children start in our Butterfly Room they are often non-verbal and avoid eye contact with those around them. Usually within a few months of working with our curriculum we see great progress in eye contact, children learning to verbalize their needs and great progress in all areas of development. Our low teacher to child ratio of 10 children to 4 teachers in our toddler classroom facilitates this wonderful growth. Over the past 7 years we have had the pleasure of working with many children who come to us with various special needs. The majority of the children with special needs who are with us in the toddler program no longer require interventional services when they go on to first grade.
