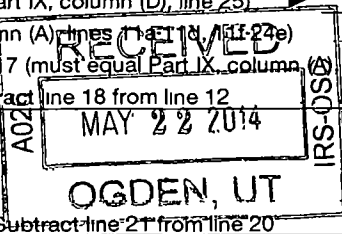

Over 6,000 canines and felines received spay or neuter services through our high volume, low cost program.
