


AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
GLYNN VISUAL ARTS, INC.

The Directors of Glynn Visual Arts, Inc., a Corporation organized and existing under the laws of the State of Georgia, did, at a regular meeting of the Board of Directors on the 11th day of June, 2014, adopt an amendment to the Articles of Incorporation of said Corporation as set forth in the following restatement of the Articles of Incorporation, which restated Articles supersede the original articles of incorporation as therefore amended.

I.

The name of the Corporation is GLYNN VISUAL ARTS, INC. The name of the Corporation was formerly GLYNN ART ASSOCIATION, INC., which was changed by vote at the June 11, 2014 Board of Directors Meeting and Approved by the Secretary of State of Georgia on August 22, 2014.

II.

The duration of the existence of the Corporation shall be perpetual.

III.

This Corporation is organized pursuant to the provisions of the Georgia Non-Profit Corporation code and exclusively for charitable, scientific, literary

and educational purposes as may qualify it as exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

More specifically, such purposes include:

1. To foster, encourage and develop public appreciation of all art forms, and of the visual arts in particular; to provide means, equipment and facilities to afford the general public an opportunity to acquire knowledge of the arts, and practical experience in the creation and appreciation of art in all its forms; to cultivate, promote, foster, sponsor, and develop the understanding, taste, and love of the arts; including the conduct of workshops to support a continuing education function for the public in the arts.

2. To have and exercise all powers necessary or convenient to effect any and all of the purposes for which the Corporation is organized.

IV.

The Corporation is to have members as provided in the By-Laws.

V.

The Board of Directors shall be selected by the members as provided for in the By-Laws.

VI.

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or to otherwise attempt to influence legislation, and the Corporation shall not participate in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

VII.

The remaining assets of the Corporation, in the event of dissolution or final liquidation, shall be applied and distributed as follows: All liabilities and obligation of the corporation shall be paid, satisfied and discharged, or provision shall be made therefor; any assets held on the condition that they be

returned, transferred or conveyed upon dissolution shall be disposed of in accordance with such requirements; all remaining assets of every nature and description whatsoever, shall be distributed to one or more corporations, funds or foundations, qualified for exemption from tax as an exclusively charitable or educational fund or foundations under Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States internal Revenue Law).

VIII.


The Corporation shall have all of the powers and privileges enumerated in the Official Code of Georgia, Section 14-3-21, and as the statute may be amended from time to time giving or granting additional or qualifying said powers in the future.

Said amendment was adopted by a unanimous vote of the directors then in office and the restated articles as herein set forth merely restate all of those provisions then in effect not being amended by such new amendment or amendments.
