28 Annual meeting of membership - papers presented and speakers on current topics. Representing 67 of the nation's universities, the NAUFRP has focused recent efforts on a number of emerging topics. It has worked with public and private sector partners to identify and prioritize a national research agenda, and formed alliances with other non-governmental organizations on a range of issues including natural resource sustainability, renewable energy, and climate change. In 2013, NAUFRP implemented action items identified in its Undergraduate Education Strategic Plan, and worked on planning and organization for the International Union of Forestry Research Organizations to be held in Salt Lake City, UT October 5-11, 2014.

29 Liaison with USDA research and education programs, which has identified critical needs in graduate education, and resulted in a USDA National Needs Fellowship Program. NAUFRP collaborated with the Society of American Foresters on issues such as accreditation, in particular, development of a new accreditation for Natural Resources and Ecosystem Management. NAUFRP celebrated the 50th anniversary of the enactment of the McIntire-Stennis Cooperative Forestry Research Program, and highlighted the accomplishments of the Cooperative Forestry Research Program after 50 years. NAUFRP also participated in the Farm Bill Coalition and Climate Change Working Groups on issues related to forestry and forestry research, and documented student enrollment trends in natural resources.
