INTERNATIONAL EXPERTS TUCI STAFF PROVIDE MANY PRESENTATIONS, LEAD GROUP DISCUSSIONS AND PROVIDE CONSULTATIONS THROUGHOUT THE METRO AREA IN ADDITION TUCI PROVIDES PHYSICAL SPACE IN OUR OWN FACILITY FREE OF CHARGE FOR NOT FOR PROFIT ORGANIZATIONS WITH AN INTEREST IN CHILDREN'S ISSUES TO HOLD MEETINGS TUCI HAS DEVELOPED A MULTIMEDIA PRESENTATION THAT RUNS CONTINUOUSLY IN OUR LOBBY ABOUT EARLY BRAIN DEVELOPMENT WE REQUEST THAT ALL GROUPS THAT USE OUR FACILITY MAKE AN EFFORT TO GO THROUGH THIS EXHIBIT IN THE HOPE THAT IT WILL BE ANOTHER WAY TO INCREASE THEIR SENSITIVITY TO THE IMPORTANCE OF EARLY BRAIN DEVELOPMENT TUCI STAFF HAVE ALSO SERVED AS FACILITATORS FOR A VARIETY OF CHILD RELATED COALITIONS THAT HAVE AS A GOAL BRINGING COMMUNITY GROUPS WITH SIMILAR INTERESTS TOGETHER IN ORDER THAT THEY MIGHT SHARE EXPERIENCES, GAIN INSIGHT INTO WHAT OTHERS ARE DOING AND POTENTIALLY DEVELOP COLLABORATIVE PROJECTS IN THESE TYPES OF COLLABORATIVE, TUCI STAFF ORGANIZE AND LEAD THE GROUPS AND TUCI PROVIDES THE SPACE, EQUIPMENT, REFRESHMENTS ETC OTHER DISSEMINATION EFFORTS INCLUDE TALKS PROVIDED TO VARIOUS COMMUNITY GROUPS BY STAFF FROM TUCI THE TUCI STAFF ALSO HELPS COMMUNITY GROUPS WITH THE DEVELOPMENT OF THEIR OWN EARLY BRAIN AWARENESS MESSAGES THE BEST EXAMPLE OF THIS IS THE COLLABORATION WITH THE NEIGHBORHOOD CHRISTIAN CENTERS TWO TO FOUR TIMES A MONTH, TUCI STAFF BRIEF ON OUR WEBSITE AND SENDS THESE BRIEFS TO OVER 2000 RECIPIENTS IN THE REGION THESE ARE LITERATURE AND DATA BASED DESCRIPTIONS OF WHAT'S GOING ON IN MEMPHIS AND HOW OTHER COMMUNITIES HAVE ADDRESSED SIMILAR ISSUES EXTERNAL SUPPORT PROVIDED BY TUCI TO NOT FOR PROFITS IN THE COMMUNITY HAVE PRIMARILY GONE TO THREE GROUPS IN 2013 TUCI MADE CONTRIBUTIONS TO LEBONHEUR CHILDREN'S HOSPITAL OF OVER \$2 MILLION THIS IS PART OF AN OVERALL \$25 MILLION COMMITMENT THAT TUCI HAS MADE TO LEBONHEUR AND WAS USED IN PART IN THE CONSTRUCTION OF THE NEW HOSPITAL AN ADDITIONAL CONTRIBUTION OF MORE THAN \$1 MILLION IN 2013 WENT TO SUPPORT A LONG TERM RESEARCH PROJECT THAT IS BEING PERFORMED BY THE UNIVERSITY OF TENNESSEE'S DEPARTMENT OF PREVENTIVE MEDICINE CALLED THE CONDITIONS AFFECTING NEUROCOGNITIVE DEVELOPMENT AND LEARNING IN EARLY CHILDHOOD STUDY (CANDLE) THIS IS A PROSPECTIVE STUDY DESIGNED TO DETERMINE WHAT SPECIFIC FACTORS DURING THE FIRST THREE YEARS OF A CHILD'S LIFE CAN BE IDENTIFIED THAT INFLUENCE BRAIN DEVELOPMENT THE ULTIMATE OUTCOME FROM THIS STUDY MAY HAVE IMPORTANT NATIONAL IMPLICATIONS BY COMBING INFORMATION FROM THE CLINICAL PART OF THIS STUDY, WITH GENOMIC INFORMATION FROM BIOLOGICAL SPECIMENS FOR THE MOTHERS AND CHILDREN WILL POTENTIALLY PROVE USEFUL IN UNDERSTANDING WHY SOME CHILDREN ARE BETTER PREPARED FOR SCHOOL, MORE LIKELY TO BE OBESE, HAVE ASTHMA, ETC TO THIS POINT THE STUDY HAS BEEN SUCCESSFUL IN NOT ONLY ENROLLING SUBJECTS BUT ALSO IN RETAINING THE MEMBERS OF THE COHORT FINALLY, TUCI HAS PROVIDED MAJOR SUPPORT TO A COMMUNITY SERVICE ORGANIZATION CALLED NEIGHBORHOOD CHRISTIAN CENTERS (NCC) HISTORICALLY THIS GROUP HAS FOCUSED ON THE MASLOVIAN NEEDS OF THE CLIENTS THEY SERVE THAT ARE AMONG THE MOST DISADVANTAGED IN OUR COMMUNITY IN THIS EFFORT, NCC TOUCHES AS MANY AS 40,000 LIVES/YR SUPPORT OF THE NCC BY TUCI HAS AS AN ULTIMATE GOAL THE STRENGTHENING OF PROGRAMS FOCUSED ON PREGNANT WOMEN AND THEIR YOUNG CHILDREN AND IN BRINGING THE MESSAGE OF THE IMPORTANCE OF THE FIRST THREE YEARS OF LIFE TO THESE AT RISK FAMILIES THE NCC HAS STARTED A PROGRAM BASED UPON OUR SUPPORT CALLED OPERATION SMART CHILD AND HAS BEGUN DEVELOPING A CURRICULUM FOR THE EDUCATION YOUNG PREGNANT WOMEN AND THEIR FAMILIES A CORE ELEMENT OF THIS PROGRAM IS A UCI DEVELOPED CONCEPT OF TEACHING PARENTS AND PROVIDERS ABOUT THE IMPORTANCE OF TOUCHING, TALKING, READING AND PLAYING WITH THEIR CHILDREN ALL OF THE ACTIVITIES ARE IMPORTANT FOR NORMAL CHILD DEVELOPMENT, ARE EASY TO DO AND COST VERY LITTLE IF ANYTHING AS PART OF THE CURRICULUM, INFORMATION ABOUT BRAIN DEVELOPMENT IS INCLUDED
