MHC is open from 1-3PM on Monday, Tuesday, Wednesday, Friday and Saturday. MHC provides 3-4 days' worth of emergency food, once per month. The exception is people without cooking facilities, who are able to come weekly and receive a smaller portion. Food is obtained through donations of food or money from individuals, through grants from several community organizations, and through the Federal government's TEFAP (The Emergency Food Assistance Program), which gave us nearly 140,000 pounds of food in 2013. We are also able to purchase some food at a good price (18 cents/pound) from the Central & Eastern NC Food Bank when it is available. We also have quarterly food drives where volunteers ask for donations at local grocery stores.

During 2013 MHC served 32,980 individuals. There were 14,154 families. 7,933 were children under 18; 4,176 were between 55-65 years of age; and 1,840 were over 65. Individuals with no stoves totaled 1,600.

A total of approximately 594,000 pounds of food was distributed to clients in 2013.
