Adopt-the-Atlanta BeltLine

In 2013, 54 adopter groups participated in the program, with 797 volunteers contributing 1,998 volunteer hours of service on their adopted segments. Three new adopter segments were opened through the course of the year.

Advocacy

Park Pride coordinates advocacy efforts for parks through our PARC Program. PARC (Parks Atlanta Rescue Coalition), For more than a decade, PARC has rallied support around a shared agenda of improving Atlanta's parks and greenspaces to positively impact Atlantans' quality of life, public health, the environment and economy of the city. In 2013, PARC developed a "Park Pledge" outlining the four key points requiring community and city commitment in order to improve the state of parks in Atlanta:

1. Adequate funding of operations and maintenance of Atlanta's parks;
2. Acquisition of additional parks to ensure all Atlantans live within a 10 minute walk of a park;
3. Provide programs at parks that encourage healthy, active kids and engaged communities;
4. Make all parks safe, crime-free areas.

The pledge was endorsed by all Atlanta City Council Members, Mayor Kasim Reed, greenspace advocacy organizations and citizens.

Annual Parks and Greenspace Conference

More than 350 people, including interested citizens, park professionals, corporate representatives and others, attended Park Pride's 12th Annual Parks & Greenspace Conference. Reflecting the theme for the event "Activating Parks for Healthy Communities", the sessions and tours explored how parks are essential to a community's physical, mental, emotional and economic health.

Community Gardens

In 2013, Park Pride provided ongoing support for 19 neighborhood groups and non-profit organizations that have established community gardens in City of Atlanta parks, and helped a group secure the necessary approvals for a 20th. Through the Community Gardening program, Park Pride connects gardeners to local resources for gardening and provides opportunities for networking. In June, we hosted a well-received tour of four of our community gardens, providing an opportunity for gardeners to network, share ideas and gain inspiration from each other.

Fiscal Partners

In 2013, Park Pride had 48 active Fiscal Partners who raised \$321,979 for capital improvements to their parks. Fiscal Partners represent a diverse group of park advocates from neighborhoods throughout the City, working on a wide range of projects. Partner projects range from a few hundred dollars to cover the cost of materials for a volunteer project, to hundreds of thousands of dollars to add new amenities to a park.

Program Service Accomplishments

Friends of the Park

The Friends of the Park program engaged park enthusiasts focused on 49 parks in the City of Atlanta and 40 parks in DeKalb County. Activities led by Friends of the Park groups included: a tour in DeKalb highlighting community/county partnerships, a grant workshop held to prepare groups applying for grants to complete community driven projects, a DeKalb Friends of the Park “thank you” reception at Porter Sanford Art, walks organized with a naturalist at Cascade Springs, and a field day in Candler Park. Throughout the year we shared opportunities for networking across parks and building relationships with park leadership, including monthly PARC (Park Atlanta Rescue Coalition) meetings, quarterly Greenspace Meetings of Atlanta’s Parks Commissioner and monthly meetings of DeKalb’s Citizen Advisory Board meetings.

Grant Programs

In 2013, Park Pride announced funding awards of more than \$625,000 for 17 community park improvement projects to be completed by May 2015. The funds allocated for these projects will be spent on project expenses as they are incurred in 2014 and 2015.

- 10 Community Building Grants awarded totaling \$149,000
Matching grants ranging from \$6,000 to \$50,000 will help communities implement lasting park improvements. (*City of Atlanta and DeKalb*)
- 7 Legacy Grants awarded totaling \$476,250
Matching grants ranging from \$50,000 to \$100,000 support community implementation of comprehensive park visions and master plans. (*City of Atlanta only*)

During 2013, over \$480,000 was spent on projects awarded funding in previous years.

Volunteers

In 2013, Park Pride coordinated 4,677 volunteers in 97 group projects in Parks across Atlanta and DeKalb County. Corporate groups, student groups and civic minded organizations made significant impacts to parks by lacing up their boots and getting their hands dirty. The groups, ranging from five volunteers to more than two hundred, accomplished a variety of projects including: invasive removal, erosion control, forest restoration, new trail construction and beautification. These groups provided a total of 15,097 hours of volunteer service to 42 parks throughout Atlanta and DeKalb County.

Visioning

In 2013, the Visioning team continued to work on securing greenspace in the Proctor Creek watershed and teamed with The Conservation Fund to develop the English Avenue community's first public park at Lindsay Street. An additional parcel was acquired for Vine City Park and the dilapidated building on the site was demolished to make way for expansion of the park.

Visioning reports were published for:

Mountain Way Common - An innovative addition to the greenspace inventory in Buckhead, this heavily wooded site consists of approximately 7 acres under GA 400. A special agreement between GDOT and the City of Atlanta allows recreational uses on this highway right-of-way.

Jennie Drake Park – the plan for this west Atlanta park proposes soft-surface trails, woodland restoration and seating areas in the newly acquired woodland.
