Our purpose is to facilitate Christian mission activities through the use of volunteers. We organize the logistics and ministry for church teams, school groups, and individuals wanting to serve short-term in Alaska and Romania.

Facilitated 75 church groups and school groups involving 1120 people from Lower 48 states who came to Alaska to serve. Our expenses included housing, volunteer staff hosting, airport transfers, all meals, transportation and all ministry set up. These teams worked in Anchorage, Wasilla, Palmer, Kenai, and also several remote Native villages. Most of the work was with disadvantaged children and youth -- feeding 10,526 (non-government funded) meals in the parks to children, conducting religious and recreation programs in local parts. Sponsored week camp for 48 children/youth from disadvantaged homes. Program expenses also include all team food expenses, vehicles expenses, housing expenses, volunteer staff expenses, GraceWorks Grandview Baptist, supplies for doing the local park ministry, mission aviation, and 90% of Scott Kirby Salary package. Expenses also include renovations/upgrade of our housing facility. Revenue includes funds from participants, gifts for mission aviation, contributions for missionary Scott Kirby, and designated gifts for carrying on the Alaska work - including buying food for the children in the

Facilitated one volunteer team to Romania in November involving 20 people. Team preached in small village churches, and worked with children.
