The Septima Clark Community Power Institute is a month-long summer leadership development institute for 25-30 high-school aged youth as participants and 5-6 college-aged young people as Action Team Leaders. Youth Speak Truth Radio Program engages 20-30 people aged 13-18 from the Atlanta community to create and produce 26 bimonthly public affairs programs called "Youth Speak Truth" on a community-based radio station. Additionally, youth members organize regionally and locally to advance Education Justice goals, including participating in the National Student Bill of Rights efforts.
