FOR SOME CHILDREN, THESE ARE THE FIRST BOOKS THEY HAVE EVER ACTUALLY OWNED. MANY OF THEM ONLY HAVE ACCESS TO BOOKS THROUGH THEIR SCHOOL LIBRARY. MAKING CHILDREN AND TEENS PROUD BOOK OWNERS IS A KEY COMPONENT TO HELPING THEM DEVELOP A LOVE OF BOOKS AND READING.

THROUGH OUR BOOKS FOR NASHVILLE KIDS PROGRAM, BOOK'EM PROVIDED MORE THAN 36,000 BOOKS TO ABOUT 80 DIFFERENT NONPROFITS, SCHOOLS AND GOVERNMENT AGENCIES, WHO GAVE THEM TO THOUSANDS OF UNDERPRIVILEGED YOUTH IN THE NASHVILLE AREA.
