Southern Foundation continued a program began in 2011. Family Day Care Home is a state program for feeding children administered by the MS Department of Education. We sponsor individuals to feed children and we earn a small administrative fee for doing so. We also receive reimbursement for certain other operational expenses. The expenses associated with this endeavor are listed in Part IX, Statement of Functional Expenses, under the various expense categories. I combined three non-labor expenses to Line 24e and attached a note of explanation in Form O for Line 24e. The revenue is listed in Part VIII, Statement of Revenues, on Line 2f.
