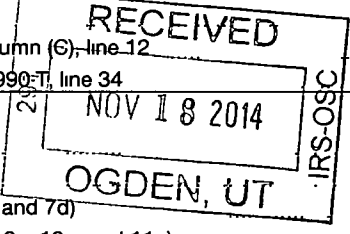

THE DAVID TOMS CHARITABLE FOUNDATION HAS BUILT A STATE-OF-THE-ART GOLF PRACTICE FACILITY AND YOUTH ACADEMY. IT IS A 60-ACRE GOLF ACADEMY THAT OPENED IN SEPTEMBER 2013. THE PROGRAM IS KNOWN AS THE "DAVID TOMS ACADEMY" OR "265". THE ACADEMY IS AFFILIATED WITH THE FIRST TEE OF NORTHWEST LOUISIANA AND WORKS WITH CHILDREN FROM ALL BACKGROUNDS. THE ACADEMY WAS ONLY OPEN FOR THREE MONTHS DURING 2013. WHEN FULLY OPERATIONAL, PLANS CALL FOR THE ACADEMY TO WORK WITH OVER 400 CHILDREN EACH YEAR. "265" WAS ESTABLISHED TO TEACH THE PROPER ETIQUETTE, RULES, HISTORY AND TRADITIONS OF GOLF TO AREA YOUTH. IT IS THE BELIEF OF THE FOUNDATION LEADERSHIP THAT THROUGH THESE TEACHINGS, THEY WILL BE ABLE TO IMPROVE CHILDREN'S LIFE SKILLS THROUGH SELF-ESTEEM, INTEGRITY, SPORTSMANSHIP AND RESPONSIBILITY. The David Toms Academy opened on October 1, 2013. On October 19, 2013, we held our first event that was designed to improve the lives of children through the use of our facility and golf. We hosted over 20 kids that had ties to the local Elks Club Lodge. These children, ages ranging from 10 to 16, came from various socio-economic backgrounds. We had males and females as well and children from different races.

We had three golf instructors that worked with the kids on the fundamentals of the game for over 2 hours. We also provided equipment to those who did not have golf clubs. Following the golf instruction, we had pastor Chris Hough from Trinity Baptist Church speak to the children about life lessons, decision making and peer pressure. We also provided everyone with lunch.



The David Toms Academy awarded two full “scholarships” to high school students. Calvary junior Nathan Jeansonne and Byrd junior Jeff Berry were selected based on their grades, personal interview, golf ability and financial need. These two students were given complimentary access to the Academy to work on their golf games and enhance their chances of obtaining college golf scholarships. Both of these fine young men have improved immensely and have signed college golf scholarships (one to LSU and one to Louisiana Tech).



The David Toms Academy partnered with the First Tee of Northwest Louisiana to provide complimentary clinics to youth from our region. Because of the weather and daylight issues, we were only able to host 2 clinics in 2013 (have had many clinics in 2014). These clinics included golf instruction and complimentary equipment to over 50 kids, almost all from underprivileged backgrounds.
