The Older Americans Act (OAA) Program is a federal program that provides assistance to older persons and caregivers and is the only federal supportive services program directed solely toward improving the lives of older people. The Organization contracts with 17 providers to offer a wide range of services to clients. This contract provided 12,385 unduplicated older persons and caregivers with services during 2008. The Alzheimer's Disease Initiative program ensures that persons afflicted with Alzheimer's disease and other forms of dementia, are given essential services to help them age in place, in an elder-friendly environment, with security, dignity, and purpose.
