Part III Statement of Program Service Accomplishments

Mission: FCAN Foundation conducts research and public education on Florida consumer issues and seeks to empower consumers to fight back on utilities, health care, insurance, federal budget issues, the environment, and financial services reform. FCAN Foundation sponsors non-partisan voter registration drives, voter education, and "Get Out The Vote" campaigns.

YES – FCAN Foundation began the East Tampa Civic Engagement Project – a continuation of past similar work, but not conducted last year. The campaign included voter registration, civic engagement help, and voter assistance.

Exempt Purpose Achievements:

- a Organize Florida Civic Engagement Project (Expenses \$2,500)– FCAN Foundation worked to increase civic engagement in Orange County Florida with this project. Organize Now created the Orange Rising coalition consisting of 23 different organizations working in the county to continue the fight to hold county officials accountable for their disenfranchisement of tens of thousands of Orange County residents.

East Tampa Civic Engagement Project (Expenses \$5,000) Although similar to the Organize Florida CE project, the East Tampa project focused on low income and minority neighborhoods in East Tampa that were underrepresented in the civic process. The FCAN Foundation worked to increase civic engagement by going door to door and stationing staff at high traffic locations to tell residents about upcoming elections and offer voter registration or change of address services. About 10,000 voters were registered or updated.

- c Federal Issues Project. (Expenses: \$9,900) The FCAN Foundation funded education of consumers on federal issues including the impacts of federal tax and budget decisions on the lives of everyday Floridians. FCAN Foundation worked with the USAction Education Fund preparing and releasing information on how federal issues impact Floridians. FCAN Foundation contracted with FCAN for this project.
- d Consumer Education Project (Expenses \$ 2,743) FCAN Foundation provided information to consumers, conducted research, and worked on insurance, utility, and environmental policy at the state and national levels. Work included a web site, printed materials, and media work by program staff and telephone canvassers. FCAN Foundation contracted with FCAN for this project.

- e. Health Care Project (Expenses \$6,300) FCAN Foundation worked with Florida CHAIN, the state's leading health care organization. Assist in organizing activities in the Tampa Bay area that support the Medicaid expansion campaign. This included recruiting organizations and individuals to participate. FCAN Foundation contracted with FCAN for this work.
- f. War on Poverty (Expenses \$4,500) FCAN hired a Tallahassee based organizer for this project which focused on Florida foreclosure laws. We provided expertise, authored a white paper, and hosted two seminars on the issue.
