SECOND AMENDED AND RESTATED BYLAWS OF

THE CELIA LIPTON FARRIS AND VICTOR W. FARRIS FOUNDATION. INC.

A Florida Not For Profit Corporation

ARTICLE I PURPOSE AND RESTRICTIONS

1.01 <u>Purpose</u>. The Celia Lipton Farris and Victor W. Farris Foundation. Inc. (the "<u>Foundation</u>") is a Florida not for profit corporation, organized for the purpose of financially assisting and aiding any cause, Community Chest, fund, foundation or other organization organized and operating for exclusively religious, charitable, scientific, literary or educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding provision of any future United States Internal Revenue Law (the "<u>Code</u>") or the regulations promulgated thereunder (the "<u>Ireasury Regulations</u>").

1.02 Restrictions.

- (a) No part of the earnings of the Foundation shall inure to the benefit of any director or officer of the Foundation, or to any other person (except that the Foundation may pay reasonable compensation for services rendered to or on behalf of the Foundation and make other payments and distributions in furtherance of one or more of its purposes), and no director or officer of the Foundation. or any other person shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Foundation. The Foundation shall pay no dividends.
- (b) The Foundation shall not participate, directly or indirectly, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Foundation shall not have objectives nor engage in activities that would characterize it as an "action organization" as defined in Treasury Regulations.
- (c) Notwithstanding any other provision of these articles, the Foundation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Code.
- (d) In any taxable year in which the Foundation is a private foundation as described in section 509(a) of the Code, the Foundation (1) shall distribute its income for such period at such time and manner as not to subject it to tax under section 4942 of the Code; (2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code; (3) shall not retain any excess business holdings as defined in Section 4943(c) of the Code; (4) shall not make any investments in such manner as to subject the Foundation to tax under Section 4944 of the Code; and (5) shall not make any taxable expenditures as defined in Section 4945(d) of the Code.

(e) Upon the dissolution of the Foundation, the Board of Trustees will, after paying or making provision for the payment of all the liabilities of the Foundation, dispose of all the assets of the Foundation exclusively for the purposes of the Foundation in such manner, or to such organization or organizations organized and operated exclusively for scientific, educational or charitable purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Code, as the Board of Trustees of the Foundation shall determine.

ARTICLE II MEMBERS

- 2.01 <u>Classes of Membership</u>. The Foundation shall have two (2) classes of members: Voting Members and Nonvoting Members. All references in these Bylaws to "Member(s)" shall mean Voting Members and Nonvoting Members, unless otherwise expressed. The membership records of the Foundation shall properly indicate whenever a Member is a Voting Member or a Nonvoting Member, but failure to do so shall not change such person's status from Nonvoting Member to that of Voting Member.
- 2.02 <u>Membership Requirements</u>. Except as otherwise provided in <u>Section 2.15</u>, only the lineal descendants of Victor W. Farris and Celia Lipton Farris who have reached the age of majority under the laws then in effect in the State of Florida and who are otherwise legally competent may serve as Members of the Foundation. Each lineal descendant of Victor W. Farris and Celia Lipton Farris who has reached the age of majority under the laws then in effect in the State of Florida and who is legally competent and otherwise qualified to serve under the laws governing the Foundation which are then in effect in the State of Florida shall be automatically admitted as a Nonvoting Member of the Foundation.
- 2.03 <u>Change of Member Class</u>. Except as otherwise provided in <u>Section 2.15</u>, upon the vote of a majority of the current Voting Members of the Foundation, the class designation of a Member may be changed from (a) Nonvoting Member to Voting Member or (b) Voting Member to Nonvoting Member.
- 2.04 <u>Term of Membership</u>. A Member of the Foundation shall continue to serve as a Member until the earliest of his or her: resignation: disability (as defined in <u>Article IX</u> of these Bylaws); loss of qualification to serve under the laws governing the Foundation which are then in effect in the State of Florida; removal; or death. A Member may resign at any time by delivering written notice to the President of the Foundation. A resignation is made effective when notice is delivered unless the notice specifies a later effective date. A Member may be removed as a Member of the Foundation by the vote or written consent of a majority of all of the Voting Members.
- 2.05 Annual Meeting. An annual meeting of the Members shall be held at the time and place designated by the President of the Foundation for the purpose of the election of Trustees and the transaction of such other business as may come before the Members.
- 2.06 <u>Special Meetings.</u> Special meetings of the Members may be called by the President of the Foundation or at the request of at least two (2) Voting Members. The person

or persons calling the special meeting of the Members in accordance with these Bylaws may designate any place as the place for holding any special meeting of the Members called by them. If no designation is made, the place of meeting shall be the principal office of the Foundation.

- 2.07 <u>Meetings of the Members by Means of a Conference Telephone or Similar Communications</u>. The Members may participate in a meeting of the Members by means of a conference telephone or similar communications equipment if all persons participating in the meeting can hear each other at the same time. Participation by such means shall constitute presence in person at a meeting.
- 2.08 Notice of Meetings. Notice of all meetings shall be given at least two (2) days before the time of the holding of the meeting. Notice in each case shall specify the place, day, and hour of the meeting. Notice of meetings shall be in writing and delivered personally, mailed, or delivered by an overnight courier/delivery service (such as Fedex, UPS, or the like) to the Members at their respective addresses, as they appear on the books of the Foundation. Without limiting the manner by which notice otherwise may be given effectively, notice of meetings may be given by means of electronic transmission (including e-mail and facsimile) in accordance with applicable law. Notice shall be given by the Secretary, or in his or her absence or upon his or her failure to act, by a person designated by the President of the Foundation.
- 2.09 Quorum and Voting. A majority of the Voting Members shall constitute a quorum for the transaction of business at meetings of the Members. Every act or decision done or made by a majority of the Voting Members shall be regarded as the act of the Voting Members, unless a greater number shall be required by the Articles of Incorporation or these Bylaws, or the provisions of Chapter 617 of the Florida Statutes.
- 2.10 <u>Waiver of Notice</u>. The transactions of any meeting of the Members, however called and noticed or wherever held, shall be valid as though voted on at a meeting of the Members held after appropriate notice if a quorum is present and if, either before or after said meeting, each of the Voting Members not present signs a written waiver of notice, a consent to holding the meeting or an approval of the minutes. The waiver of notice or consent need not specify the purpose of the meeting. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting. Notice of a meeting shall also be deemed given to any Member who attends the meeting, without protesting the lack of notice to that Member, before such meeting or at its commencement.
- 2.11 <u>Fees and Compensation of Members.</u> The Members shall serve without compensation for serving as Members; provided however, the Members shall be entitled to reimbursement for reasonable expenses incurred in connection with the performance of their duties, including reasonable travel and lodging expenses to attend meetings of the Members.
- 2.12 <u>Action Without Meeting.</u> Any action required or permitted to be taken by the Voting Members may be taken without a meeting, if two-thirds the Voting Members shall individually or collectively consent in writing prior to that action being taken. Such action by written consent shall have the same force and effect as a unanimous vote of the Voting Members. Without limiting the manner by which written consent may otherwise be given

effectively, a written consent may be given by means of electronic transmission (including e-mail and facsimile). Such written consent or consents shall be filed with the minutes of the proceedings of the Members. Prompt notice of the taking of the corporate action without a meeting by less than unanimous written consent shall be given to those Voting Members who have not consented in writing, and who, if the action had been taken at a meeting, would have been entitled to notice of the meeting.

- 2.13 <u>Property Rights.</u> No member shall have any right, title, interest or privilege of, in or to any of the property or assets, including any earnings or investment income of the Foundation, nor shall any of such assets or property be distributed to any member on the dissolution or winding up thereof.
- 2.14 <u>Liability of Members</u>. No member of the Foundation shall be personally liable for any of its debts, liabilities or obligations nor shall any member be subject to any assessment.
- 2.15 Special Voting Membership of George F. Farris. Upon the death of Celia Lipton Farris, George F. Farris was automatically elected as a Voting Member of the Foundation. Subject to the removal restrictions set out in Section 3.17 (regarding Trustees). George F. Farris shall continue to serve a Voting Member of the Foundation until the earlier of his: resignation; disability (as defined in Article 1X of these Bylaws); loss of qualification to serve under the laws governing the Foundation which are then in effect in the State of Florida; removal for cause (as defined in Section 3.17); or death.

ARTICLE III BOARD OF TRUSTEES

- 3.01 Number, Tenure and Qualifications. The business and affairs of the Foundation shall be managed by a Board of Directors composed of at least three (3) but no more than nine (9) members. The Board of Directors shall also be known as the "Board of Trustees." and each Director may also be referred to as a "Trustee." The powers of the Board of Trustees shall specifically include the right to select and remove all officers, agents, and employees of the Foundation, to prescribe any powers and duties for them that are consistent with (a) law, (b) the Foundation's Articles of Incorporation, and (c) these Bylaws, and to fix their compensation. Each Trustee shall serve for a period of one (1) year and until his or her successor has been elected or until his or her earlier resignation, removal from office, or death. The number of Trustees may be increased or decreased from time to time, as the Board of Trustees may determine; however, the number of Trustees shall not be fewer than three (3). Trustees need not be residents of the State of Florida. Any person qualified to serve under the laws governing the Foundation which are then in effect in the State of Florida may serve as a Trustee of the Foundation.
- 3.02 <u>Election of Trustees</u>. The Voting Members of the Foundation shall elect the Trustees at the annual meeting of the Members by a vote of the majority of the Voting Members. If Trustees are not elected at the annual meeting, each incumbent Trustee shall continue in office until his or her successors are qualified and elected.

- 3.03 Removal of Trustees. Subject to the removal restrictions applying to George F. Farris in Section 3.17, any member of the Board of Trustees may be removed from office with or without cause at any time by the vote or written consent of a majority of all of the Voting Members. If removal is effected at a meeting, any vacancies created thereby may be filled by the Voting Members at the same meeting.
- 3.04 <u>Resignation of Trustees</u>. A Trustee may resign at any time by delivering written notice to the Board of Trustees. A resignation is made effective when notice is delivered unless the notice specifies a later effective date. If a resignation is made effective at a later date, the Board of Trustees may fill the pending vacancy in accordance with <u>Section 3.05</u> before the effective date if the Board of Trustees provides that the successor does not take office until the effective date. No reduction of the authorized number of Trustees shall have the effect of removing any Trustee before that Trustee's term of office expires.
- 3.05 <u>Vacancies on Board of Trustees</u>. Whenever any vacancies shall occur on the Board of Trustees by death, resignation, or removal, the same may be filled by the affirmative vote of a majority of the remaining Trustees though less than a quorum of the Board of Trustees, and the Trustee(s) so elected shall hold office only until the next annual meeting of the Members. Whenever vacancies shall occur on the Board of Trustees as a result in the increase in the number of Trustees, such vacancies shall be filled by a majority vote of the Voting Members.
- 3.06 Annual Meeting. An annual meeting of the Board of Trustees shall be held at the time and place designated by the President of the Foundation for the purpose of the election of officers and the transaction of such other business as may come before the Board of Trustees. In addition, the Board of Trustees may, at any time and from time to time, provide by resolution, the time and place (either within or outside of the State of Florida) for the holding of the annual meeting of the Board of Trustees, without the need for any other notice. If no designation is made, the place of meeting shall be the principal office of the Foundation.
- 3.07 Regular Meetings. In addition to the annual meeting, the Board of Trustees may hold other regular meetings at such times as shall be fixed by the Board of Trustees. The Board of Trustees may publish a schedule of regular meetings to be held during the course of the ensuing year, and notwithstanding Section 3.10, such additional regular meetings may be held without any additional notice.
- 3.08 Special Meetings. Special meetings of the Board of Trustees may be called by the President of the Foundation or at least two (2) of the members of the Board of Trustees. The person or persons calling a special meeting of the Board of Trustees in accordance with these Bylaws may designate any place as the place for holding the special meeting of the Board of Trustees called by such persons. If no designation is made, the place of meeting shall be the principal office of the Foundation.
- 3.09 <u>Meetings of the Board of Trustees by Means of a Conference Telephone or Similar Communications</u>. Members of the Board of Trustees may participate in a meeting of the Board of Trustees by means of a conference telephone or similar communications

equipment if all persons participating in the meeting can hear each other at the same time. Participation by such means shall constitute presence in person at a meeting.

- 3.10 Notice of Meetings. Notice of all meetings shall be given at least two (2) days before the time of the holding of the meeting. Notice in each case shall specify the place, day and hour of the meeting. Notice of meetings shall be in writing and delivered personally, mailed, or delivered by an overnight courier/delivery service (such as FedEx, UPS, or the like) to the Trustees at their respective addresses, as they appear on the books of the Foundation. Without limiting the manner by which notice otherwise may be given effectively, notice of meetings may be given by means of electronic transmission (including e-mail and facsimile) in accordance with applicable law. Notice shall be given by the Secretary, or in his or her absence or upon his or her failure to act, by a person designated by the President of the Foundation.
- 3.11 Quorum and Voting. A majority of the Trustees shall constitute a quorum for the transaction of business at meetings of the Board of Trustees, except to adjourn as hereinafter provided. Every act or decision done or made by a majority of the Trustees present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board of Trustees, unless a greater number shall be required by the Articles of Incorporation, these Bylaws, or the provisions of Chapter 617 of the Florida Statutes. A meeting at which a quorum is initially present may continue to transact business notwithstanding the withdrawal of Trustees, if any action taken is approved by at least a majority of the required quorum for that meeting. In the event of a tie vote, then the Trustees present and eligible to vote shall draw lots and the vote of the Trustee drawing the voting lot shall decide the issue and shall constitute the act of the Board.
- 3.12 <u>Waiver of Notice</u>. The transactions of any meeting of the Board of Trustees, however called and noticed or wherever held, shall be valid as though voted on at a meeting of the Board of Trustees held after appropriate notice if a quorum is present and if, either before or after said meeting, each of the Trustees not present signs a written waiver of notice, a consent to holding the meeting, or an approval of the minutes. The waiver of notice or consent need not specify the purpose of the meeting. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting. Notice of a meeting shall also be deemed given to any Trustee who attends the meeting without protesting the lack of notice to that Trustee, before the meeting or at its commencement.
- 3.13 Adjournment. A majority of the Trustees present, whether or not constituting a quorum, may adjourn any meeting to another time and place.
- 3.14 Notice of Adjournment. Notice of the time and place of holding an adjourned meeting need not be given, unless the meeting is adjourned for more than twenty-four (24) hours, in which case notice of the time and place shall be given before the time of the adjourned meeting, in the manner specified in Section 3.10 of this Article, to the Trustees who were not present at the time of the adjournment.
- 3.15 Fees and Compensation of Trustees. Trustees and officers shall serve without compensation, except as otherwise determined by the Board of Trustees; provided however, the Trustees shall be entitled to reimbursement for reasonable expenses incurred in connection with

the performance of their duties, including reasonable travel expenses to attend meetings of the Trustees.

- 3.16 Action Without Meeting. Any action required or permitted to be taken by the Board of Trustees may be taken without a meeting, if two-thirds of the Board of Trustees shall individually or collectively consent in writing prior to that action. Such action by written consent shall have the same force and effect as a unanimous vote of the Board of Trustees. Without limiting the manner by which written consent may otherwise be given effectively, a written consent may be given by means of electronic transmission (including e-mail and facsimile). Such written consent or consents shall be filed with the minutes of the proceedings of the Board of Trustees. Prompt notice of the taking of the corporate action without a meeting by less than unanimous written consent shall be given to those Trustees who have not consented in writing, and who, if the action had been taken at a meeting, would have been entitled to notice of the meeting.
- 3.17 Special Appointment of George F. Farris. Upon the death of Celia Lipton Farris, George W. Farris was immediately and automatically elected Trustee of the Corporation for so long as he is able and willing to serve in such capacity. Notwithstanding any provision of these Bylaws to the contrary regarding the removal of a Member, Trustee, or Officer of the Foundation. George F. Farris may be removed solely in the event of his: disability (as defined in Article IX of these Bylaws); loss of qualification to serve under the laws governing the Foundation which are then in effect in the State of Florida; death; or being the subject of a finding of "cause." For purposes of these Bylaws, the term "cause" is defined to mean: the commission of a felony; or, as such acts relate to his duties as a Trustee or Officer of the Foundation, personal dishonesty, incompetence, breach of fiduciary duty, gross negligence, or willful misconduct.

ARTICLE IV COMMITTEES

- 4.01 <u>Committees of the Board of Trustees</u>. The Board of Trustees may designate from among its members an executive committee (the "<u>Executive Committee</u>") of not less than two (2) nor more than seven (7) members, which shall have and may exercise all the authority of the Board of Trustees between Board of Trustees meetings except that the Executive Committee shall not have the authority to: (a) fill vacancies on the Board of Trustees or any committee thereof; or (b) adopt, amend, or repeal the Bylaws. The Board of Trustees may designate from among its members additional standing committees including, but not limited to, a Nominating Committee, an Investment Committee, an Audit Committee, and a Management and Governance Committee, which committees shall possess and exercise such authority in the management of the business of the Foundation as the Board of Trustees shall determine and set forth in a written resolution or resolutions.
- 4.02 Adjunct Committees. The Board of Trustees may appoint one or more committees for the purpose of fostering the Foundation's mission. The committee(s) created pursuant to this Section 4.02 shall serve only in an adjunct capacity to the Board of Trustees, and such committees (and their respective members) shall have no legal authority to act for or bind the Foundation. Members of all adjunct committees shall be appointed by the Board of

Trustees, but need not be members of the Board of Trustees. The Board of Trustees shall appoint the chairman of each adjunct committee. Such chairman shall be a Trustee and shall preside at, and shall fix the place, time, and date of, the committee meetings. All committees shall be under the control of the Board of Trustees and shall have charge of such duties as may be assigned to them by the Board of Trustees. Adjunct committees shall meet as frequently as may be necessary or appropriate. The Board of Trustees may remove any member of a committee with or without cause. The Board of Trustees may terminate the existence of any committee at any time.

ARTICLE V OFFICERS

- 5.01 Officers. The officers of the Foundation shall be a President, a Secretary, and a Treasurer. The Foundation may also have, at the discretion of the Board of Trustees, one or more Vice Presidents, and such other officers as may be determined by the Board of Trustees. Any number of offices may be held by the same person; provided however, no officer shall execute, acknowledge or verify any instrument in more than one capacity.
- 5.02 Appointment and Term of Office. The officers of the Foundation shall be appointed annually by the Board of Trustees at its annual meeting. If the appointment of officers does not occur at this meeting, the appointment shall occur as soon thereafter as practicable. Each officer shall hold office until a successor has been duly appointed and qualified, or until his or her earlier resignation, removal from office, or death.
- 5.03 <u>Removal of Officers</u>. The Board of Trustees may remove any officer of the Foundation from his or her office or position at any time, with or without cause.
- 5.04 <u>Resignation of Officers</u>. Any officer of the Foundation may resign from his or her office or position, at any time, by delivering notice to the President. Such resignation is effective when the notice is delivered unless the notice specifies a later effective date. If a resignation is made effective at a later date and the corporation accepts the future effective date, the Board of Trustees may fill the pending vacancy before the effective date if the Board of Trustees provides that the successor does not take office until the effective date.
- 5.05 <u>President.</u> The President shall be the chief executive officer of the Foundation and shall have general supervision, direction, and control of the business and the officers of the Foundation. The President shall preside at all meetings of the Foundation. The President shall have the general powers and duties of management usually vested in the office of President of a Foundation, and shall have such other powers and duties as may be prescribed by the Board of Trustees or the Bylaws. The President must be a Voting Member of the Foundation.
- 5.06 <u>Vice Presidents</u>. In the absence of the President or in the event of his or her inability or refusal to act, the Vice President (or in the event there be more than one Vice President, then the Vice Presidents in the order designated at the time of their election; or in the absence of any such Vice Presidential designation order, then in order of their election) shall perform the duties of the President; and, when so acting, the Vice President shall have all the powers of and be subject to all the restrictions upon the President. The Vice Presidents shall

have such other powers and perform such other duties as from time to time may be prescribed for them, respectively, by the Board of Trustees or the President of the Foundation.

- 5.07 Secretary. The Secretary shall keep, or cause to be kept, at the principal office or such other place as the Board of Trustees may direct, a book of minutes of all meetings and actions of Trustees and committees of Trustees. Such meeting minutes shall include: the time and place of holding; whether regular or special, and if special, how authorized; the notice given; the names of those present; and a record of the proceedings. The Secretary shall give, or cause to be given, notice of all meetings required by the Bylaws or by law to be given, keep the seal of the Foundation (if one is adopted) in safe custody, and shall have such other powers and shall perform such other duties as may be prescribed by the Board of Trustees or by the Bylaws.
- 5.08 Treasurer. The Treasurer shall keep and maintain, or cause to be kept and maintained, adequate and correct accounting records of all transactions of the Foundation including accounting for its assets, liabilities, receipts, disbursements, gains, and losses. The Treasurer shall deposit, or cause to be deposited, all moneys and other valuables in the name and to the credit of the Foundation with such depositaries as may be designated by the Board of Trustees. The Treasurer shall prepare, or cause to be prepared, financial statements on a periodic basis including a statement of financial position, a statement of activities, and a statement of cash flows, together with (a) such other statements as may be requested by the President or the Board of Trustees and (b) such other statements as may be required to be in compliance with not-for-profit accounting. The Treasurer shall have such other powers and perform such other duties as may be prescribed by the Board of Trustees or Bylaws.
- 5.09 Special Appointment of George F. Farris. Upon the death of Celia Lipton Farris, George F. Farris was immediately and automatically elected President of the Foundation for so long as he is able and willing to serve in such capacity. Notwithstanding any provision of these Bylaws to the contrary regarding the removal of a Member, Trustee, or Officer of the Foundation, George F. Farris may be removed solely in the event of his: disability (as defined in Article IX, below); loss of qualification to serve under the laws governing the Foundation which are then in effect in the State of Florida: death; or being the subject of a finding of "cause." For purposes of these Bylaws, the term "cause" is defined to mean: the commission of a felony: or, as such acts relate to his duties as a Trustee or Officer of the Foundation, personal dishonesty, incompetence, breach of fiduciary duty, gross negligence, or willful misconduct.

ARTICLE VI GRANTS

6.01 President's Fund. There shall be deemed a "President's Fund" which shall not exceed \$25,000 in any calendar year. The President, in the President's sole discretion and without further approval by the Board of Trustees, shall be authorized to distribute from the President's Fund, to such one or more recipients (and only such recipients) as would otherwise be qualified to receive grant distributions from the Foundation and in such amount(s), up to an aggregate maximum of \$25,000 in any calendar year, as the President deems appropriate.

6.02 <u>Grant-Making Policy</u>. With the exception of discretionary distributions which may be made by the President from the President's Fund, the Foundation's grant-making policies shall be set, and decisions to make or withhold grants shall be made, by the majority of the Board of Trustees.

ARTICLE VII BOOKS AND RECORDS

The Foundation shall maintain accurate and complete accounting records and shall keep records of minutes of all meetings of its Board of Trustees, a record of all actions taken by the Board of Trustees without a meeting, and a record of all actions taken by a committee of the Board of Trustees in place of the Board of Trustees on behalf of the Foundation. The Foundation shall keep a copy of the following records: (a) its Articles or Restated Articles of Incorporation and all amendments thereto currently in effect; (b) its Bylaws or Restated Bylaws and all amendments thereto currently in effect; (c) a list of the names and business street addresses of its current Members, Trustees, and officers; and (d) its most recent annual report delivered to the Department of State (or, if electronic reporting is used, then a copy of the Florida Department of Revenue's electronic records report and receipt for its most recent annual report so filed). Any books, records, and minutes may be in written form or in any other form capable of being converted into written form within a reasonable time.

ARTICLE VIII INDEMNIFICATION

This Foundation shall indemnify its members, directors, and officers to the fullest extent permitted by the provisions of the Florida General Corporation Act and the Florida Not For Profit Corporations Act, as the same may be amended and supplemented, from and against any and all of the expenses or liabilities incurred in defending a civil or criminal proceeding, or other matters referred to in or covered by said provisions, including advancement of expenses prior to the final disposition of such proceedings and amounts paid in settlement of such proceedings. The indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any bylaw, agreement, vote of disinterested directors, or otherwise, both as to action in his or her official capacity and as to action in another capacity while holding such office. The right to indemnification shall continue as to a person who has ceased to be a member, director or officer and shall inure to the benefit of the heirs, executors, and administrators of such a person, and an adjudication of liability shall not affect the right to indemnification for those indemnified.

ARTICLE IX MISCELLANEOUS

9.01 <u>Corporate Seal</u>. The Board of Trustees may provide for a corporate seal which may be facsimile, engraved, printed, or an impression seal which shall be circular in form and shall have inscribed thereon the name of the corporation, the words "seal" and "Not-for-Profit, Florida" and the year of incorporation.

- 9.02 Execution of Contracts. The Board of Trustees, except as may be otherwise provided in these Bylaws, may authorize any officer or officers, employee or employees, agent or agents, to enter into any contract or execute and deliver any contract or other instrument in the name of and on behalf of the Foundation, and such authority may be general or confined to specific instances. Unless authorized so to do by these Bylaws or the Board of Trustees, no officer or agent or employee shall have any power or authority to bind the Foundation by any contract or engagement, or to pledge its credit, or to render it liable pecuniarily for any purpose or in any amount.
- 9.03 Deposits. All funds of the Foundation not otherwise employed shall be deposited from time to time to the credit of the Foundation in such banks, trust companies, or other depositories as may be designated from time to time by: the Board of Trustees; a committee of the Board of Trustees to which the Board may delegate such power; or any officer or officers, employee or employees, or agent or agents of the Foundation to whom such power may be delegated by the Board of Trustees or by such committee. For the purpose of such deposit, all checks, drafts, and other orders for the payment of money which are payable to the order of the Foundation may be endorsed, assigned, and delivered by any officer of the Foundation or in such other manner as may from time to time be determined by resolution of the Board of Trustees or of such committee.
- 9.04 <u>Borrowing, Checks, Drafts, Etc.</u> The Foundation, whenever its general interests require, may borrow money, obtain credit and issue evidences of indebtedness for the repayment thereof, guarantee evidences of indebtedness or other types of securities issued by others, and may assign and grant interests in any property or assets of the Foundation as security for such debts and obligations. All promissory notes, guarantees, checks, drafts, or other evidences of indebtedness issued in the name of the Foundation shall be signed or endorsed by such officer or officers, employee or employees, or agent or agents of the Foundation, as shall from time to time be determined by resolution of the Board of Trustees or the Executive Committee.
- Disabled/Disability. For purposes of these Bylaws and the governance of the 9.05 Foundation, provisions referring to an individual being "disabled" or under a "disability" shall refer to an individual who is or becomes incapable, by reason of physical or mental impairment, of performing the essential functions of his or her duties on behalf of the Foundation, for a period of ninety (90) days during any one hundred eighty (180) day period. Either of the following shall be conclusive, but not exclusive, determination of an individual being so disabled or under such a disability: (a) a decision to that effect by a majority of the Voting Members (other than the affected individual) based upon the Foundation's receipt of a certificate or letter from a licensed medical doctor in active practice who (i) is not an employee of or otherwise affiliated with the Foundation and (ii) has examined the individual within the forty-five (45) days immediately preceding the Foundation's receipt of such certificate or letter. stating that, because of illness or incapacity of any kind, the affected individual is unable to effectively evaluate matters relating to the proper management of relatively sophisticated financial affairs or is unable to effectively comprehend and properly manage relatively sophisticated business affairs; or (b) a formal adjudication of incompetency is entered against the individual by a court of competent jurisdiction.

- 9.06 Notices. All notices, requests, consents and other communications to the Foundation (including correspondence to an officer of the Foundation or to the Board of Trustees) shall be in writing and shall be (as elected by the person giving such notice): (a) hand delivered by messenger or courier service: (b) transmitted by fax: (c) mailed by registered or certified mail (postage prepaid), return receipt requested: or (d) sent by overnight courier/delivery service (such as Fedex, UPS, or the like) addressed to the Principal Office of the Foundation. Each such notice shall be deemed delivered (a) on the date delivered, if by messenger or courier service: (b) on the date of the confirmation of receipt, if by fax; and (c) either upon the date of receipt or refusal of delivery, if mailed or sent by overnight courier/delivery. Without limiting the manner by which notice otherwise may be given effectively, notice of meetings may be given by means of electronic transmission (including e-mail) in accordance with applicable law.
- 9.07 <u>Gender, etc.</u> All pronouns shall be deemed to refer to the masculine or feminine, or singular or plural, as the identity of the person(s) may require.

ARTICLE X AMENDMENTS

These Bylaws may be altered, amended, or repealed and new Bylaws may be adopted by a vote of two-thirds of all of the Voting Members of the Foundation. Bylaws may be neither amended nor repealed nor may new Bylaws be adopted at any meeting unless the notice of such meeting shall contain a description of the proposed changes in the Bylaws.
