**Property Management:** ACT managed five major preserves with public access, and several smaller conservation properties around Alachua County and North Central Florida. ACT's land management activities include forest, groundcover, and wetlands restoration, creating and maintaining public trails and informational kiosks, the application of prescribed fire, and exotics control. ACT benefitted from the use of many dozens of volunteers from the University of Florida, Santa Fe College and the community at large, as well as from County court-ordered Community Service workers, who provided significant additional staffing for these activities. ACT also submitted a successful application for State Bureau of Historic Preservation funding (to be awarded in 2014) that will facilitate much-

**Education and Outreach:** ACT conducted approximately three dozen environmental education classes/workshops and ten public concerts. ACT's Prairie Creek Lodge hosted innumerable meetings and special events, many of which were conducted by or in partnership with other non-profits and government agencies, including the Springs Institute, the Florida Organic Growers' Association, Conservation Burial, Inc., the Florida Trail Association, Forage Farm, Blue Oven Kitchens, the Florida Wildlife Federation, Paddle Florida, Inc., University of Florida's Office of Sustainability, University of Florida Environmental Law Clinic, University of Florida School of Forestry, the Sea Turtle Conservancy, the Hogtown Brewers' Association, and various local and state agencies. ACT also

**Acquisitions:** ACT acquired an additional 390-acre conservation property in Putnam County, thereby increasing the Little Orange Creek Preserve to 2,368 acres. Cost of this purchase was \$508,000, and funding was provided through a grant from the US Fish & Wildlife Service. In addition, ACT initiated negotiations for fee simple donations and acquisitions in several north central Florida counties, and wrote successful proposals for foundation funding that will result in additional Little Orange Creek acquisitions in 2014.

Only Tuscahilla Preserve includes a conservation easement. The monitoring and enforcement endowments for all other conservation easements were invested with Florida Capital Bank. Only the interest in these endowments can be used for monitoring and the principal may be used for enforcement. The financial statements include the following footnote related to conservation easements: "Property owners grant to the Corporation conservation easements that restrict the owner's use of the land in perpetuity. Some allow the Corporation to conduct research and studies on the properties. Since the Corporation does not receive any rights to the property, the Corporation
