IT WAS DESIGNED TO PROVIDE TEMPORARY RELIEF AND WELLNESS AID TO THE ECONOMICALLY DISADVANTAGED AND HEALTH-STRESSED FAMILIES AND INDIVIDUALS THROUGH LOCAL SERVICING NONPROFIT AGENCIES AND SCHOOLS. THE GOAL IS TO STRENGTHEN THE OUTREACH EFFORTS OF OTHERS WHO ARE RESPONSIBLE FOR IMPLEMENTING PROGRAMS AND STRUCTURED ACTIVITIES THAT PROMOTE HOPE, HEALTH AND HAPPINESS. EACH WELLNESS-MEDICAL AID PACK CONTAINS VARIOUS PRODUCTS IN UP TO THREE CATEGORIES--FOOD SUPPLEMENTS, PERSONAL HYGIENE PRODUCTS AND OVER-THE-COUNTER MEDICINES. IT MAY CONTAIN A SMALL PAMPHLET ABOUT HOW TO MAINTAIN A HEALTHY DIET FOR INDIVIDUALS LIVING ON OR BELOW A POVERTY LEVEL INCOME, A MAP CONTAINING A LIST OF HUMANITARIAN ASSISTANCE CENTERS SUCH AS FOOD BANKS, EMERGENCY SHELTERS AND FREE CLINICS, ETC. LOCATED THROUGHOUT THE TAMPA BAY AREA, AND OTHER BASIC NEEDS TYPE OF INFORMATION SUCH AS TRANSPORTATION OPTIONS, DISCOUNT PROGRAMS, COUPONS, ETC. PACKS MAY BE CUSTOMIZED BASED ON THE NEEDS OF OUR CLIENTS IN AN EFFORT TO SUPPORT THE HEALTH AND WELLNESS NEEDS OF ELEMENTARY STUDENTS IN TITLE 1 SCHOOLS, VARIOUS EDUCATIONAL ACTIVITIES ARE USED TO PROMOTE THE PROGRAM AND THE LEARNING PROCESS. IN 2013, PINELLAS COUNTY SCHOOLS RECEIVED ANOTHER 17,280 TOOTHBRUSHES AND TRAVEL CAPS FOR DISTRIBUTION BY SCHOOL NURSES TO ITS FIRST AND FOURTH GRADERS TO REINFORCE THE LESSONS ON THE IMPORTANCE OF CONSCIENTIOUS DENTAL HYGIENE BY PROVIDING THE TOOLS NECESSARY FOR THE STUDENTS TO USE THESE LESSONS AT HOME. A TOTAL OF 21 NONPROFITS RECEIVED VARIOUS TYPES OF DISTRIBUTIONS FROM THE GIVE HOPE USA PROGRAM IN 2013. IN AN EFFORT TO HELP SUSTAIN THE PROGRAM, CHARITY WORKS WILL CONTINUE TO MARKET IT TO MANUFACTURERS AND DISTRIBUTORS FOR PRODUCT PLACEMENT AND BRANDING CONSIDERATIONS.
