Pursuant to the provisions of KRS Chapter 273, the following Articles of Amendment to the Articles of Incorporation of **CHARLES W. ROSENBAUM FOUNDATION, INC.**, a Kentucky nonprofit corporation ("Corporation"), are hereby adopted:

1. The name of the Corporation is Charles W. Rosenbaum Foundation, Inc.
2. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

**"ARTICLE I**

The name of the Corporation is Michael and Chandra Rudd Foundation, Inc."

3. Article VI of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

**"ARTICLE VI**

**Membership**

The sole member of the Corporation shall be Michael D. Rudd. Upon his death or incapacity, the sole member of the Corporation shall be Chandra Z. Kreuzer, if she is then living. Upon the death of the last to survive of Michael D. Rudd or Chandra Z. Kreuzer, the Corporation shall have no members unless this Article VI is amended to provide for one or more members and such amendment is unanimously approved by the full Board of Directors. In the event that the Corporation no longer has a sole member, all powers expressly conferred upon the sole member by these Articles shall be disregarded.

4. The amendment was adopted by the Corporation's Board of Directors by unanimous written consent effective as of May 1, 2013, and submitted for approval by the Corporation's sole member. The sole member adopted the amendment by written consent on May 1, 2013, such consent being sufficient for approval of the amendment."


