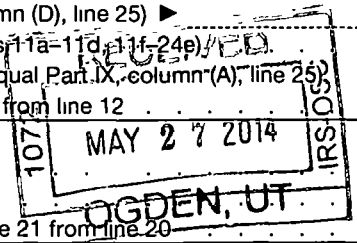

 To provide an enrichment center for individuals with special needs. The center is designed to improve the lives of individuals through a variety of vocational, educational, social, and motivational activities.  
 To develop a residential living community empowering those with special needs to advance in life skills, spiritual growth, and self esteem, as well as to give individuals an opportunity to be contributing members of the community.

**REACH HIGH EDUCATIONAL AND PRE-VOCATIONAL DAY PROGRAM**  
 Reach High is a day program for students with special needs who are no longer in school, age 18 and above. This is a year-round program conducted Mondays through Thursdays. Reach High has a maximum enrollment of 15 students which was met during 2013.  
 This program provides extended opportunities to reinforce education and social skills as well as to provide pre-vocational training. Students maintain and enhance skills learned in school (such as reading and math) and gain new skills in an environment stressing teamwork and positive interactions with peers, teachers, and guests.  
 The pre-vocational and social aspects of the program prepare students for jobs in the community. Local companies provide work within the program, which improves skills and the feeling of self-worth and teamwork among students.

4b (Code: 611600 ) (Expenses \$ 41,932 including grants of \$ ) (Revenue \$ 11,023 )  
**AFTERNOON ENRICHMENT CLASSES**  
 These classes are designed for individuals with special needs age eight and above. There are six 6-week sessions each year with an average enrollment of 60 students participating in one or more classes.  
 Sixteen weekly classes are offered after regular school hours for recreation, life skills, arts and crafts, and academic enrichment. Recreational classes include group fitness activities on several levels such as Zumba, Yoga, and Fit-and-Fun. Cooking classes and computer classes add to life skills. Arts and crafts classes provide opportunities for individuals to use creativity for relaxation and enjoyment in addition to giving an opportunity to share creations with others. Other educational classes are reading, community-based math, Bible adventures, and newspaper reporting.  
 An underlying purpose of each class is the social development of the individual including communication skills, following directions, and encouraging positive interactions with other students, teachers, and volunteers. The development of lasting peer relationships has been a natural result of participation in these classes.

4c (Code: 611600 ) (Expenses \$ 3,541 including grants of \$ ) (Revenue \$ 2,574 )  
**SUMMER CAMPS AND ART CLASSES**  
 A one-week summer camp is conducted for children age six through eleven. Occupational Therapy students from Texas Tech University conduct the day camp with physical activities, crafts, and a focus on social interaction.  
 A two-week summer day camp is for secondary students age twelve and above. The "Time Traveler" theme utilized in 2013 incorporated history in crafts, physical activities, music, and group activities. There are 45 campers divided into smaller groups, where individual and team achievements are recognized.  
 The summer art classes are conducted by a professional artist and highly skilled volunteers. By following directions closely, participants produce art on canvas suitable for framing and gift-giving.
