In 2013 Second Source funding of the construction of a new Samaritan House in partnership with Appalachian Outreach of Carson

Newman College came to an end with the completion of the shelter. Appalachian Outreach operates the shelter as a ministry to homeless families and single women.

Throughout the year Second Source Thrift Store continued it's support of Appalachian Outreach operations (\$5000.00 per month plus occasional funding in response to specific needs). Additional warehouse space was leased for 6 months by Second Source for use by Appalachian Outreach. (\$800.00 per month starting in July 2013).

In December 2013, Second Source Thrift Store purchased a vacant manufacturing company's building on a 10 acre track of land in Jefferson City's Industrial Park (S11 Municipal Drive).

Available reserve funds (\$75,000.00) were used as down payment and a five year loan was taken out for the balance (\$292,000.00) from FSG Bank. The facility will become the Ministry Center for Appalachian Outreach operations of home repair, clothing, food and furniture distribution and offices. When the property is paid for the facility will be donated to Appalachian Outreach.
