SOME OF THE SERVICES INCLUDE EMPLOYMENT READINESS TRAINING AND THE SUPPORT ITEMS NEEDED FOR EMPLOYMENT INCLUDING PLACEMENT ASSISTANCE, TRANSITIONAL HOUSING, MAIL SERVICE, CLOTHING AND MUCH MORE INCLUDING THE COORDINATION OF THE ACTIVITIES OF OTHER AGENCIES IN THE DELIVERY OF SOCIAL SERVICES. IN 2013, OSDN SERVED 1712 MAN AND WOMEN VETERANS. 90% OF OUR TOTAL FUNDING WENT TO DIRECT SUPPORT OF VETERANS AND THEIR FAMILIES.
