In 2013, Amistad Mission served the medical, emotional, educational, and spiritual needs of 99 at-risk children and young adults between the ages of 1 to 28 years through its supporting programs in Villa Amistad, two youth houses, and young adult independent life. Among these 99 children and young adults, Amistad supported 70 children living in Villa Amistad (between the ages of 1 to 17 years), 20 youth living in either the agency's boys or girls youth house (between the ages of 15 and 21 years), and 9 young adults (between the ages of 21 and 28 years) living independently in apartments in the City of Cochabamba. Among the 70 children living in Villa Amistad, all students advanced to the next corresponding grade level. Among the youth and young adults, Amistad supported 19 students in university and technical school. Beginning in March 2013, Amistad Mission expanded its reach to serve the needs of at-risk young children and families through a daycare and pre-K Montessori named "Arca de los Ninos." Located several blocks above Villa Amistad, this school in 2013 served 28 children from five months to 6 years. Amistad collaborated with the local neighborhood association to provide full-day education and nutritious meals to these children. Seeing the success of this program, the local neighborhood association pledged greater funding and a building expansion of the center that has been completed.

Through Amistad Mission's rural integral development program in the region of Tapacari, with concentration in the village of Aramasi, 64 children in three communities (including Aramasi) participated in Amistad's "Growing Up Playing" program, in which they learned important agricultural skills, principles of leadership, children's rights education, and respect for the environment. Of these 64 children, 55 maintained their own gardens, providing for the nutritional needs of their families. In addition, 60 children successfully raised small animals for consumption through this program, providing much needed protein for the family's nourishment. Also, in Aramasi Amistad's "Sowing Hope" program that teaches women leadership and microenterprise skills trained 47 women through workshops and expansion of the existing weaving cooperative and wheat mill. This program has led to an important growth in respect for women's rights and decision-making within their homes, as well as providing greater economic solvency for their families.
