The Foundation conducted various golf tournaments and promoted Junior Golf in the state of Mississippi * The Foundation conducted a US Kids Local Tour exposing children to golf at an early age and through a developmental, learning friendly tour Parents are encouraged and required in some age divisions to caddie for the players on the US Kids Tour * The Foundation hosted a junior pro am in conjunction with the local PGA tour event for the top 36 junior players aged 12 through 18 The players were paired with PGA Tour players and played in the junior pro am on the championship course during tournament week * The Foundation sponsored a team of 12 players (6 girls & 6 boys) to travel to Hot Springs, Arkansas to play in the inaugural Southern States Junior Cup Matches Three other states competed, Arkansas, Oklahoma, and Missouri The players competed in four-ball, foursome, and singles matches against the junior players from the other states The Organization paid for part of the players' travel, entry fee, and uniforms * The Foundation hosted the MS/LA Junior Cup Matches at Greenwood CC These matches were comprised of the top junior players from Mississippi and Louisiana, ages 10-18 (both boys & girls) Each state alternates in hosting the matches each year The Foundation hosted a dinner during the matches to honor the players The players play four-ball and singles matches * The Foundation also provided rules education seminars during the summer season in conjunction with tournaments * During the MS Cup Matches dinner-awards were presented to players of the year in each age division and an overall male and female player of the year The Foundation also awarded the Robbie Webb award to a person who unselfishly gave time and resources to junior golf and a sportsmanship award to the junior player who exemplified good sportsmanship behavior on and off the golf course (Grants \$ 0) If this amount includes foreign grants, check here
