28 The Eagles Wings Foundation (EWF) assisted the United States Coast Guard and the Bahamian National Government during the 2013 Black Swan Mass-Rescue Operation (Full-Scale Exercise) The Black Swan exercise was the largest, most complex Full Scale Exercise in design and execution of an Offshore Mass Rescue Operation exercise in the history of the international maritime community The exercise was successfully executed in April of 2013 with 18 distinct venues geographically spanning from Florida to Freeport, Grand Bahamas Island, Bahamas EWF provided a mobile software solution that allowed field observers to report real-time updates to a central Control Center, greatly improving the situational awareness of exercise personnel (Grants \$ 30,811) If this amount includes foreign grants, check here

29 The Eagles Wings Foundation (EWF) has been developing a strategic partnership with the United States Air Force Academy (USAF A), including securing a signed Cooperative Research and Development Agreement (CRADA) In addition to signing the CRADA agreement, EWF has assisted USAFA during a pilot project in Palm Beach County in which 6 USAFA cadets conducted business assessments to identify critical nodes in the infrastructure and supply chain networks that sustain major life support and revenue-generating economic activities in the County In addition, the cadets also assessed the likelihood of damage to critical infrastructure and supply chain networks, using geospatial data to assist with the project Vulnerability assessments for these critical nodes were generated based on simulated hurricane damage (Grants \$ 30,810) If this amount includes foreign grants, check here
