

Busting the Shale Bubble Hype As PCI's comprehensive analysis and communication tools demonstrate, the so-called "Shale Revolution" is simply a bubble, inflated by record levels of drilling, speculative leasing and flipping, fee-driven promotion by investment banks, and unsustainably low natural gas prices. Post Carbon Institute has partnered with Energy Policy Forum, Earthworks, and Physicians, Scientists, and Engineers for Healthy Energy to equip policymakers, media, and concerned citizens with empirical data and tools to show that "fracking" won't solve our energy woes. Richard Heinberg's newest book *Snake Oil: How Fracking's False Promise of Plenty Imperils Our Future* was published in 2013. Heinberg casts a critical eye on the oil-industry hype that has hijacked America's energy conversation. This is the first book to look at fracking from both economic and environmental perspectives, informed by the most thorough analysis of shale gas and oil drilling data ever undertaken.

Energy Reality Campaign: Working with environmental and energy groups, advocates, and thought leaders from across the spectrum, the Energy Reality Campaign is creating a systemic understanding of the interrelationships between energy, the economy, and the natural world. PCI is collaborating with Foundation for Deep Ecology and hundreds of allies to engage environmental and political leaders - and through them, their constituencies. We offer activists the tools to build energy literacy. The program's goal is to shift the public conversation from wanting more to needing less, and valuing what we have.

We're tapping into the human experience through narrative, humor, imagination, and animation to engage a broad community of thought leaders, concerned individuals and communities, allies, and press. Together, we're moving beyond the debate about whether we should transition to a post-carbon world, and into a rich dialogue about how we can best move forward.
