Document the Violation.

The superintendent of the Region in which the conservation easement is located, or a staff assigned by him, should visit the site to inspect and carefully document the violation. The violation must be described in detail, including location and extent.

Photos keyed to a photomap should be taken, signed and dated by the photographer.

Quantitative measurements of the violation should be noted as appropriate, e.g. area of impact, number of trees damaged. Field notes should be signed and dated by the person conducting the inspection.

Contact the Landowner.

The superintendent of the Region in which the conservation easement is located should meet with the landowner, in person if possible, to discuss the violation, if the landowner is unaware of the situation. Listen to the landowner's explanation, ask questions, take notes, and ask them to voluntarily correct the violation, or at least to cease any further work until the matter can be reviewed by CTPR's Land Acquisition Committee. Document all meetings and write a follow-up letter (send certified - return receipt requested) or e-mail to the landowner confirming any agreements made on site about the restoration of the property and compliance dates.

If the landowner agrees to restore the property.

If the landowner agrees to restore the Property, the superintendent of the Region in which the conservation easement is located should send a follow up letter as soon as
