FINALLY, REDROVER RELIEF LAUNCHED AN INNOVATIVE AND LIFESAVING WEBSITE, SAFEPLACEFORPETS.ORG, A SITE WHERE DOMESTIC VIOLENCE VICTIMS CAN SEARCH FOR SHELTERS THAT WILL ACCEPT ADULT, CHILD AND ANIMAL FAMILY MEMBERS. BRINGING THE FAMILY PETS CAN BE THE DECIDING FACTOR OF WHETHER OR NOT A VICTIM WILL LEAVE THE BATTERER AND COME TO THE SAFETY OF A SHELTER, SO THIS WEBSITE PROVIDES A VALUABLE RESOURCE FOR ANY PET OWNER TRYING TO FLEE AN ABUSIVE RELATIONSHIP.
