In 2013 Ecological Rights Foundation's Humboldt Baykeeper project continued its monthly e-mailed newsletters and reports, continued its toxics initiative, including investigating and pursuing remediation of polluted industrial sites, continued its water quality monitoring program in Humboldt Bay and tributary watersheds, and continued representing conservationist stakeholders' interests in Humboldt County coastal issues, including sea level rise planning, wetlands protection, the implementation of the Marine Life Protection Act, and the Humboldt Bay Nuclear Power Plant decommissioning. Ecological Rights Foundation's Environmental Health, Awareness and Protection Campaign continued its successful work to reduce consumer exposures to toxic chemicals. ERF continued to focus on the removal of lead and other carcinogenic and teratogenic ingredients from imported consumer products, and the abatement of human health and ecological risks from dioxin and other highly toxic chemicals used to treat lumber products and utility poles. Ecological Rights Foundation continued to service its public information website in English and Spanish, as well as its Humboldt Baykeeper information website.
