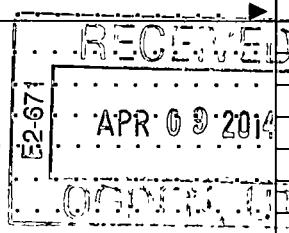



STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

During 2013, the Santa Fe Group's primary activity was a partnership with the American Dental Hygiene Association to plan and convene a symposium entitled "Transforming Dental Hygiene Education" on September 18-19, 2013 in Chicago, IL. During the event dental hygiene educators and practitioners, program directors, and association officers joined with representatives of federal agencies, philanthropy groups, oral health institutions, and other health professions to evaluate dental hygiene education and determine what could be improved to meet the oral health needs of today's American public. In addition to the symposium, the Santa Fe Group members evolved the organization's strategic direction during the January 2013 business meeting and follow up strategic planning committee discussions. The group also worked closely with another non-profit organization to dissect issues related to oral health workforce.
