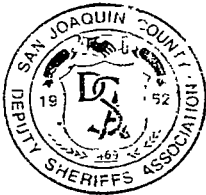



REQUIREMENTS FOR GRANTS

1. One of the applicant's parents must be an active, retired or deceased member of the DSA. They must have been a member for at least 95% of their career.
2. Applicant must be a natural child or legally adopted child. Proof may be required.
3. Membership must be in good standing, ie; dues must be current, any loans or advancements on insurance must be paid up or payments must be current.
4. To make application an Applicant must be between the ages of 17 and 25 years old.
5. Grants will be limited to (5) five years undergraduate school and (2) two years post graduate school. Any extensions or exceptions to this rule must first be approved by a 3/4 vote of the full Board of Directors of the DSA.
6. Grants will be based on income generated by the trust investments, the number of applicants and the need of the individual. The individual need will be based on the amount of other scholarships you may have received, not family income.
7. A copy of your school registration and fees must be provided.
8. **No grant will be made to an individual with a full scholarship.**
