The United Methodist Foundation of Arkansas (The "Foundation") normally receives substantial support from the general public and is organized and operated so as to attract new and additional public support on a continuous basis. The Foundation maintains a continuous and bona fide program for solicitation of funds from the general public and community.

The Foundation serves Arkansas United Methodist churches, institutions and people. It was originally chartered in 1963. It is supervised by a board of directors with thirty voting members. These thirty board members are community leaders from across the state of Arkansas. The Foundation currently serves as trustee or agent for over 500 endowments and trusts with assets of over \$128 million. The Foundation's assets and income are used for a wide array of United Methodist programs, organizations and local churches.

The Foundation seeks to assist individuals and local churches in creating and wisely managing permanent charitable funds that strengthen the ministries of the United Methodist Church. The Foundation provides a method for faithful stewards to live out their discipleship in ways that extend beyond their own lifetime. The Foundation provides services to churches and institutions by managing investment funds, creating and building permanent endowment funds, developing planned giving and education resources and investment management services.

The Foundation assists individuals in estate planning matters, serves as trustee of permanent charitable funds benefiting any United Methodist church, institution or other ministry, serves as trustee of life-income gift arrangements and revocable trusts and provides counsel on giving methods and alternatives. The Foundation helps individuals in evaluating the use of life income gift plans, provides personalized proposals that illustrate a donor's unique circumstances, assists in the preparation of trust documents and serves as trustee of these funds.

The Foundation also assists with many different kinds of gifts to enhance the ministry of Arkansas United Methodist individuals, churches and institutions. Donations of cash, securities, real estate or other property are accepted. Gifts can be made during lifetime, through a trust or planned through a donor's last will and testament.

The Foundation receives support from a large representative number of persons, rather than receiving almost all of its support from members of a single family. A portion of the Foundation's support is investment income from its endowment and trust accounts which were originally established with contributions from the general public. The Foundation is organized and operated so as to attract new and additional public support on a continuous basis.
