NOTE A: **Organization and Summary of Significant Accounting Policies**

Organization - The Arkansas Timber Producers Association is a not for profit membership organization exempt from income tax under Section 501 (c)(6) of the U.S. Internal Revenue Code.

The Association was formed in 1991 to promote and improve the logging and timber products industry in the State of Arkansas, and to promote various safety and training programs relating to improving workplace conditions and to encourage conservation when harvesting timber.

Cash Basis of Accounting - The Arkansas Timber Producers Association's accounts are maintained, and these statements are presented, on a cash basis of accounting under which only revenues collected, cost and expenses paid, assets and fund balances arising from cash transactions are recognized. Therefore , the financial statements are not intended to present the results of operations and financial position in conformity with generally accepted accounting principles.

Income Tax Status - Because the Arkansas Timber Producers Association is exempt from federal and state income taxes there is no provision for income taxes in the accompanying statements.

NOTE B: **Consideration of Credit Risk**

The Association maintain their cash in bank deposit accounts at high credit quality financial institutions. The balances, at times, may exceed federally insured limits.
