When the fund is large enough, interest will be used at the discretion of the Director for the purchase student service awards. \$13,647 was used to purchase service awards at the end of the 2012-2013 school year as requested by the band director.

Video equipment is purchased to accomplish the goals of the group. Equipment with a value of more than \$500 is included on inventory and depreciated over a five year period. Depreciation is reported on line 16.) Equipment less than \$500 is not included on inventory

All equipment purchases (Under \$500 and over \$500) is included on this line

**Line 31 Other Program Services**

Conducted fundraising using the audio and video equipment that is also used to record the band. All Volunteer labor. Dance recitals, music concert and other groups are recorded and tapes & DVDs are sold to the participants.

It is difficult to allocate expenses between the activities listed on lines 28 (direct services to the Arkansas Band), and line 31. Without quality video and audio equipment we can't accomplish either. We must do fund raising listed on line 31 in order to have the equipment to complete the services to the University of Arkansas Band; and without quality equipment, we would no longer be able to do the fund raising. New equipment and other costs were split between the two as appropriate. Also without fundraising, we would not have the income to fund items on line 29 & 30.

**Line 35**

All income is produced using volunteer labor and all income is used to support the goals of the organization as stated in our Bylaws. Pre IRS employee Mr. O'Brian employee #31-31-8, we are to check NO on line 35.
