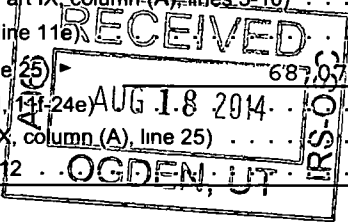

Energy Efficiency Programs: Conducted door-to-door outreach signing residents up for free: energy audits, recycling, trees and resources. We completed over 400 home energy audits in Denver and Commerce city. Low-cost and major energy upgrades, such as insulation or energy efficient appliances, were installed in many of these homes. We planted 188 trees and signed up 108 families for free recycling services.

4b (Code:) (Expenses \$ 168,055. including grants of \$ 0.) (Revenue \$ 177,808.)

Green Team Youth Employment Program: GWD employed 31 youths who worked in urban gardens and on neighborhood improvement and civic engagement projects related to environmental issues as well as healthy eating and active living. Twelve of the young people provide rehabilitation restoration and enhancement work at Rocky Mountain Arsenal and in Denver Natural Areas. In addition, started a peer-to-peer mentoring program where older Green Team members worked with 16 middle school students.

4c (Code:) (Expenses \$ 135,233. including grants of \$ 0.) (Revenue \$ 108,435.)

Transportation Demand Management Project: Provided individualized alternative transportation resources and promoted Smartphone resources for households in northwest Denver to mitigate vehicular congestion and pollution. There were 999 participating households, resulting in a reduction of 214,000 single-occupant vehicle (SOV) trips and 1,230,000 vehicle miles traveled (VMT). Started a study of barriers to transit use among low-income, Spanish speaking residents living near new light rail stations.
