**Statement of Request for Abatement of
Late Filing Penalties**

Global Charitable Foundation, Inc. is submitting Forms 990-PF for the 2013 through 2015 tax years. The organization believes that it has reasonable cause for late filing.

Global Charitable Foundation Inc. is a non-profit private foundation that was organized in the year 1999 with the Texas Secretary of State. It was the organizer's dream that the entity provide financial support to charitable organizations to help make a difference. However, the organizer understood that more work was needed before the Foundation could get off the ground, so it was dormant for several years.

Subsequent to formation, the organization applied for its employer tax identification number in 2002 or 2003. At that time, the organization engaged its previous CPA to prepare Form 1023, Application for Recognition of Exemption under Section 501(c)(3) of the Internal Revenue Code. The organization relied on the previous CPA to timely file this Form. Since formation in 1999, with the exception of applying for an employer identification number in 2002 or 2003, the organization remained inactive until 2013. Starting in 2013, the organization began receiving donations and making qualifying distributions to public charities.

On November 15, 2016, the organization had a meeting with its new CPA firm, LaPorte CPAs & Business Advisors. At this meeting, the new CPA firm inquired about the entity's exempt status. Shortly thereafter it was discovered that the entity have no record of acceptance of tax-exempt status on file. The former CPA believes that all required forms were filed, but has no record of filing such forms.

The organization hereby requests that the Internal Revenue Service grant the entity tax exempt status beginning on January 1, 2013. Section 1.9100-1(a) of the regulations provides that the Commissioner in his discretion may, upon good cause shown, grant a reasonable extension of time fixed by the regulations for making an application of relief. Rev. Proc. 79-63, IRB no. 1979-52, lists five factors to be taken into consideration in determining whether "good cause" has been shown to warrant extension relief under section 1.9100. These factors are: (1) Due Diligence of the Taxpayer, (2) Prompt Action of the Taxpayer, (3) Intent of the Taxpayer, (4) Prejudice to the Interest of the Government, and (5) Statutory and Regulatory Objectives. The organization believes it has good cause to be granted relief.

(1) Due Diligence - The organization retained a reputable law firm to organize the entity and a reputable CPA to file the appropriate documents to obtain exempt status. This is an area where the taxpayer did not have any previous experience. The individuals that formed the organization had never before been involved in forming a tax-exempt entity. They did not have any understanding of the required tax filing obligations so they engaged a reputable CPA to lead the process. They had every reason to believe that the CPA was knowledgeable and qualified to file all required forms. The CPA had

worked with these individuals for many years and never had an issue where a tax document was not filed timely. It was the organization's belief that the CPA would inform them of all filing obligations. The CPA failed to follow up to confirm that Form 1023 was received and exempt status was granted. The attorney did all that was required of him and the taxpayer reasonably believed that the CPA had also.

(2) Prompt Action - It was believed that Form 1023 and all filing obligations were satisfied by the prior CPA. It was not until the organization met with its new CPA firm, LaPorte CPAs & Business Advisors, that this issue was discovered. On November 15, 2016, the new CPA firm inquired about the confirmation of the entity's tax exempt status. From that time, until December 2016, conference calls were held with the prior CPA to try to understand the facts and it was then that it was discovered that Form 1023 had not been filed. In January of 2017, the new CPA firm, LaPorte CPAs & Business Advisors, researched possible solutions and began gathering the data to prepare Form 1023 and Forms 990-PF. In March 2017, Form 1023 and all unfiled tax returns were submitted. Upon discovery of the error, the organization requested its new CPA firm to review this issue and help obtain exempt status.

(3) Intent - It is clear that the organization intended to file Form 1023 prior to the deadline and all actions taken were consistent as if the form was filed. The entity received charitable contributions and then disbursed these contributions to various public charities. No self dealings, compensation, or unreasonable expenses were paid by the organization.

Based on the submitted Form 1023 and the various Forms 990-PF 2013 thru 2015, the Foundation has been organized and conducted in accordance with all rules and regulations governing private foundations.

Clearly, it was the intent of the foundation to file Form 1023 and to qualify as a 501(c)(3) entity.

(4) Prejudice to the Interests of the Government - Granting of extension of time for filing Form 1023 will not prejudice the interests of the government nor cause undue administrative burden. All of the actions since the entity was formed have been on the basis that it is and was always a tax exempt organization.

Based on the submitted Form 1023 and the various Forms 990-PF 2013 thru 2015, the Foundation has been organized and conducted in accordance with all rules and regulations governing private foundations.

Clearly, there is no prejudice to the interest of the government.

(5) Statutory and Regulatory Objectives - The organization completed all the steps within its control to comply with the requirements of Reg. section 1.508-1(a)(2) by instructing its CPA to prepare Form 1023, properly executing Form 1023, and instructing its CPA to file the properly completed and executed Form 1023 with the Internal Revenue Service.

Based on the submitted Form 1023 and the various Forms 990-PF 2013 thru 2015, the Foundation has been organized and conducted in accordance with all rules and regulations governing private foundations.

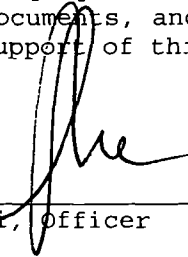
Clearly, the foundation has satisfied all of the statutory and regulatory objectives of the rules concerning private foundations.

Additionally, the Internal Revenue Service's instructions to Form 1023, Schedule E, Line 5 (page 21) allows for an extension of time to file Form 1023 beyond the 27-month period if the organization can establish that it acted reasonably and in good faith, and that granting an extension will not

prejudice the interests of the government. Examples include: (1) You filed Form 1023 before the IRS discovered your failure to file, (2) You failed because of intervening events beyond your control, (3) You exercised reasonable diligence but you were not aware of the filing requirements (the complexity of your filing and experience in these matters is taken into consideration), and (4) You reasonably relied on the advice of a qualified tax professional who failed to file Form 1023. The organization believes that it meets all of these criteria to request an extension to file Form 1023 beyond the standard 27-month period.

As stated above, the organization relied on its former CPA to prepare all required forms related to tax exempt status and compliance obligations. The organization was unaware the proper forms were not filed until it engaged a new CPA firm and discovered this omission. Accordingly, the organization respectfully requests abatement of all penalties related to the failure to file and late filing of Forms 990-PF for 2013 through 2015.
