COMMUNITY DEVELOPMENT Engaging residents to develop solutions that allow their communities to grow and prosper In 2013, Community Development's accomplishments included sustaining the Mississippi Delta Workforce Funding Collaborative (MDWFC), a public/private partnership focused on providing targeted sector strategy workforce training in the areas of healthcare and manufacturing Healthcare * Through our partnership with the Office of Nursing Workforce (ONW), we were able to take an urban model designed around Dedicated Education Units and apply it to a rural setting for the first time in Mississippi Due to the success of the program, hospitals now have a strong recruitment program for nursing students in the Mississippi Delta * Through our partnership with ONW, we were able to implement a new summer boot camp for Coahoma Community College (CCC) with all students who would be entering allied health program and nursing programs at CCC in the fall This program has better prepared the students for academic classes and clinical * Through the partnership with ONW, we have also led with incumbent workers We have had two hospitals and a local community college develop a program to allow front line workers in the hospital to attend certified nursing assistant classes The workers received a raise when they completed the class * Attracted and built out the capacity of employer champions which include Bolivar County Medical Center, Greenwood Leflore Medical Center, Delta Regional Medical Center, North Sunflower Medical Center, and South Sunflower Medical Center * To date, the healthcare partnership alone has served 974 job seekers who were students that enrolled in the allied health and nursing programs According to Department of Labor surveys, the partnership has also placed 135 job seekers in new jobs and has served over 283 incumbent workers Manufacturing * The Mississippi Delta Workforce Funding Collaborative established a new workforce intermediary with Jobs for Mississippi Graduates to help low skilled and low wage workers access credentials in the skilled trades HVAC, plumbing, welding, industrial maintenance, etc * The MDWFC also invested in manufacturing training courses with Mississippi Delta Community College, North West Community College, and Coahoma Community College to provide tuition reimbursement and transportation cost to participants Total, 42 participants have received education or industry credentials through the program The program is still in its infancy but employers immediately picked up 12 of the participants for new employment We are still waiting on employment data from the remaining participants but, with promises from the employers, we are hopeful they will find work within the industrial partnership * We have engaged multiple employers to form the industrial partnership These employers include Mars Foods, View Glass, Viking Range Corporation, Simmons Catfish, Energy, Lazy-Boy Furnishings, GE Aviation, Super Value, Delta Ag, USG Interiors, Dollar General, and Loveland * To date, the manufacturing partnership has served 72 participants total Males of Color * The Foundation has been actively looking for ways the workforce system could better tailor to the needs of males of color in the Mid South Therefore, an action plan has been developed to survey males of color focus groups This will enable the Foundation to better collect quantitative and qualitative data on this vulnerable population we are serving We plan to have results in 2014 to focus our work and move the metrics for males of color in the workforce system of the Mid South Expansion * The success of the partnership in Mississippi is leading the Foundation to replicate similar work in Louisiana and Arkansas In the past, funding opportunities have made regional work across all three states difficult However, new revenue sources have been sought to better build on our work in Arkansas and Louisiana

EDUCATION The education program area focuses on ensuring students reach academic success through high quality education The goal is to increase the number of students performing at or above proficiency on state exams Several approaches are utilized to reach this goal including strengthening the skills and capacities of teachers and administrators and supporting groups and organizations that reinforce student learning in other mediums beyond the classroom The Foundation's efforts to support stronger education systems and opportunities to enrich student learning are helping students succeed academically Below are some examples of the results that have occurred in the region through education work * Strengthened education systems serving 11,000 children most of whom participated in a free or reduced lunch program in some of the lowest resource schools in the nation * Provided intensive training to over 600 teachers and 300 administrators in 40 public schools in the Mid South Delta * Supported new, innovative learning opportunities for over 6,000 students through summer and after school programs, as well as cultural centers and museums Supporting student achievement through complimentary activities - The Foundation partners with groups and organizations that seek to enhance the student learning experience They should provide activities and support that furthers the classroom experience and enhance parent learning and understanding of education issues Latest activity results show continuous positive movement in enhancing the student learning experience A great example of our education partner is We2Gether We2Gether support efforts to foster the education and personal development success of middle and high school students through structured workshops, academic support, lifeskills learning and self-enrichment opportunities We2Gether partnered with the local school district and held a summer program for 50 K-6 youth addressing reading and health We2Gether is working in collaboration with the Sunflower County School District and Sunflower County Board of Supervisors to repair the football field formerly used by Drew High School and to make it available for recreational activities and competitions for communities and children throughout the county We2Gether is currently working with three groups of students, their parents and community members in Sunflower County, including Rome, Parchman, Drew, Ruleville, Doddsville, Moorhead, and Inverness Most of the training takes place in Drew where We2Gether is located I The first group is middle and high school students from Sunflower County schools These are the Dollars For Your Thoughts Students and their learning has included * Engaging 100 students in 20 workshops covering topics such as "You Day", Education Day, Health Day, Healthy Relationships Day, as well as Career and Future Planning Day * Engaging parents in a 1 day meeting during February regarding preparation for the student field trip * Executing a spring break summit and field trip to Orlando, Florida for 93 students * Executing 3 days of training in Orlando, including financial literacy, leadership, relationship building, dressing for success, communication skills, afternoon fun in the parks * Executing a graduation ceremony and celebration in April Graduated 93 students II The second group consists of students who graduated from phase one of the program and remained active by attending quarterly meetings for continuous learning as well as participating in community service projects These students are considered Dollars for Your Thoughts Alumni We2Gether retained 65 first year students out of a total 88 In April, 2013, 93 additional students became alumni for a total of 181 Their learning activities included * Black History Programs in February and March 2013 * Three alumni meetings focusing on health in March, April, and May 2013 * Thirty-three alumni students volunteering for the community service project committee in March, 2013 * Problem Solving For Better Health (PSBH) Workshop in March, 2013 with 33 alumni students We2Gether partnered with the Dreyfus Health Foundation, who developed the PSBH workshop * Three service project meetings in April, June, and July 2013 to prepare for project implementation * Field trip to Atlanta in May 2013 with 56 alumni students attending * Alumni meeting in September 2013 for 126 students * Hosted Alumni meeting in December 2013 for 112 students and 70 parents and other community members * Hosted a class beginning in November 2013 with 15 alumni students entitled "Teen Self-Empowerment Playshop" One of the community service projects identified during the PSBH workshop was to begin a peer group to learn how to reduce stress and find peace The idea was that reducing stress is one of the ways to prevent the prevalence of heart attacks and strokes in the Delta This class met for 10 working sessions held on Saturdays III The third group of students met during June 2013 These students were 1st-6th graders These are the YES students Class learning this year focused on reading and health A teacher from Atlanta volunteered her time for the entire month to teach the students reading and health The first and second grade met on Monday's and Wednesday's and 3rd through 6th grade met on Tuesday's and Thursday's The Foundation also hired a local teacher to assist with teaching activities which are shown below * Engaged 46 students in educational and personal development activities* Hosted parent meeting and parent breakfast in June, prior to trips * Hosted field trip to Memphis in June for 46 students * Hosted field trip to Choctaw, MS in June for 41 students and 41 parents * Presented a student performed Reader Theater Play and invited parents to attend 95% of parents were in attendance This project involved collaborating with the Dreyfus Health Foundation to do PSBH workshops and service projects in the community The workshops were carried out as planned It also involved collaborating with the Sunflower County School District to coordinate all application processing, transportation for the students, and assistance with implementation of service projects

HEALTH AND WELLNESS The Foundation invests in empowering communities and residents to take ownership and action to improve their own health The Foundation promotes healthy behaviors to reduce obesity, increasing mental health awareness to access services, and expanding access to healthcare services and education Through various partnerships with municipal leaders, faith-based organizations, schools, and businesses, over 250,000 residents are engaged in healthy behaviors such as establishing farmers markets, community gardens, and joint use agreements These various activities led to increased civic engagement amongst residents Individuals indicated they felt a sense of community when meeting at the farmers markets or participating in community health fairs Additionally, close to 1,500 residents participated in diabetes education classes and learned how to check their blood sugar on a daily basis, eat properly, and perform feet exams Mental health services, such as counseling were provided to over 500 young adults in conjunction with job training programs The services have aided in job preparedness and retention To ensure and maintain job readiness, mental health assessments are provided to every potential student In our efforts to increase access to healthcare services and education, the Foundation is working with community colleges to provide career training and job placement in nursing through an adult education program These efforts focus on partnering with local agencies to identify medical field needs as well as potential students Supportive services are also provided if needed Currently, over 500 individuals have received additional trainings and/or certifications Furthermore, the Foundation partnered with health providers and community organizations to educate residents on the Affordable Care Act

WEALTH BUILDING The Foundation's goal for the wealth building agenda is to enable families to build financial security The Foundation for the Mid South believes that building wealth requires increased access to effective financial programs and information When families possess the tools and knowledge to get their finances on track, they can begin to grow their savings, maximize their incomes and acquire assets Financial Competency Supporting activities that expand access to knowledge and resources to strengthen adult and youth financial competency Asset Building Empowering people with limited financial resources to accumulate and preserve long-term, productive assets, such as homes, education and businesses Financial Competency In partnership with LPL Financial and Foundation for Financial Planning, the Foundation continues its work to increase the financial knowledge of teachers in the Mid South The financial training is being provided in response to research that indicated that teachers were one of the most targeted groups for alternative financial services (pay day lenders, car title loans and check cashing businesses) As a result of our trainings and materials, teachers will be able to make better financial decisions, which will enable them to improve their financial security, as well as, other aspects of their lives Improved financial management can reduce stress and increase productivity and focus at work The overall goals of the training are to (1) increase financial planning competency (2) reduce the use of alternative financial services and (3) increase awareness of financial planners and their services The Foundation provided financial competency training to educators in Greenville, Greenwood and Indianola, Mississippi Also, a presentation was done with a group of superintendents to create awareness for our services Initially, the training was developed with teachers as our target participants However, in response to requests from superintendents and principals, the participants for the sessions were expanded from teachers to include assistant teachers, administrators and others involved in the education process This change was warranted, because these persons in some cases are more vulnerable than teachers due to low wages The Foundation developed special training materials for this project including a financial first aid tool kit and Did You Know card The tool kit explains how to grow and protect assets It is available on our website The Did You Know card provides information on why alternative financial services should be avoided, as well as other viable options
