WILDLIFE & BIODIVERSITY CONSERVATION EDUCATION & LEADERSHIP: We publish educational materials, maintain a reference library, provide keynote speakers, produce films, publish newsletters, attend key meetings and conferences world-wide, and issue alerts and press releases to educate the public on current wildlife conservation, habitat and biodiversity issues. 2013 conservation projects include Camp Force, a youth camp in Texas; Quest Ministries at Legends Ranch in support of the annual Special Youth Challenge Hunt for special needs children and the annual Billy Ray Parnell Memorial Purple Heart Hunt; the Clean Water Project; the Trophy Seizure Project; Ranching for Restoration Project; the Polar Bear Project, the DNA Tagging Project; the Doorway to Waterways Project; just to list a few.

COMMUNAL BASED NATURAL RESOURCES MANAGEMENT (CBNRM): The major CBNRM projects are our partnership with the Conamar Foundation in the Republic of Panama and the Robin Hurt Wildlife Foundation (RHWF) in Tanzania. We are a funding partner of the RHWF which has built 48 schools, operates 12 medical dispensaries, 2 mobile medical units, and 3 full time anti-poaching patrols fully equipped with vehicles, uniforms, etc. The project has been in continuous operation for 18 years and has grown both in scale and scope. We currently partner with 33 villages spanning 8 Districts and 7 Regions throughout Tanzania. Given the fact that 70% of all Tanzanians live at the resource base level, 40% of Tanzania's land area is covered by one form of Protected Area or another, and 30% of the total land area is covered by hunting

CONSERVATION EASEMENTS - LAND TRUST DIVISION: Conservation Force functions as a Land Trust in order to maintain wild habitats in their natural condition for their perpetual and sustainable use. We establish conservation easements on private lands to maintain wild-places for wild-life and we own and hold mitigation bank easements to restore and protect the natural, scenic or open space of land to ensure natural areas in perpetuity.

Conamar also works toward instituting conservation decrees and legislation such as the establishment of a commercial-free 20 mile tourist area starting from Pinas whereby all commercial activity is prohibited by law and with continued efforts to extend the prohibited area to 50 miles covering numerous tourist areas such as Coiba, Perlas and San Blas Islands, while working towards the elimination of long liners in these areas. Since 1997, it is illegal to kill any billfish in Panama for commercial value and since 2010, tuna boats are prohibited from fishing within the 200 mile limit of Panama waters on both oceans. CF helps hunting operators to undertake community development activities, conduct anti-poaching operations, and to develop their blocks for improved sustainability. Other CBNRM projects include our partnership with the Tembo Foundation in Tanzania, the Markhor Project in Pakistan, and the Tarpon Research Projects in Sierra Leone and Trinidad.
