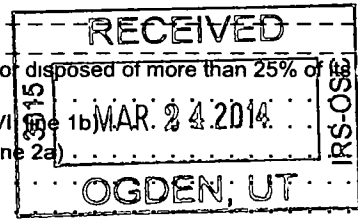

**Bylaws**

**ARTICLE 1 - BOARD OF DIRECTORS**

**1.1 General.**

The Robert L. Davison Community Development Inc. hereinafter referred to as the ("Corporation") shall be governed by a Board of Directors, hereinafter referred to as "(The Board)", which is the highest authority of the Corporation. The Board has the authority to exercise the functions and carry out the duties and responsibilities set forth in these Bylaws.

- 1.1.1** The Board may enter into contracts, make service commitments, make application for and receive grants and other, and engage in the other legal activities as may be required from time to time, to carry out the mission of the Corporation.
- 1.1.2** No individual member may act on behalf of the Board without specific authority from the Board. Likewise, no member of the Board can be held individually responsible for the actions of the Board.

**ARTICLE 2 - BOARD COMPOSITION**

**2.1 Composition of the Board.**

The Board shall have not less than nine (9) and not more than twenty-one (21) members who will serve without compensation, with a minimum of 51% residing within Jefferson Parish.

- 2.1.2** In addition to voting members, the executive director of the Corporation shall be a non-voting ex-officio member of the Board.

**ARTICLE 3 - SELECTION OF BOARD MEMBERS**

**3.1 Selection of Board Members.**

One third (1/3) of the total Board members will be elected during the annual meeting in May at two year intervals to fill the seats of those whose term expire. Board members in good standing, including any outgoing member, shall vote on a slate of candidates prepared by the nominating committee. Election will be by a two-third (2/3) vote of the board members present and voting.

- 3.1.3** The officers of the Board shall solicit applications from candidates who are willing to serve as Board members.

- 3.1.4** The nominating committee shall have the authority to nominate persons as Board members.
- 3.1.5** Board members shall have terms of six (6) years, however, initially, one third (1/3) of the Board members will serve two year term, one third (1/3) of the board shall serve a four year term, the remaining one-third (1/3) of the Board members shall serve six year term to provide staggered terms for the Board continuity. Board members will be allowed to serve two (2) consecutive terms and will be eligible for re-election after a period of one (1) year of inactive service.
- 3.1.6** The Chairman of the Board shall have the authority to designate and assign each Board member to a term period based on the staggered term limitations.

## **ARTICLE 4 - RESPONSIBILITIES**

### **4.1.1 Attendance.**

The Board shall meet no less than four (4) times annually, at quarterly intervals. Minutes of the Board meeting will be recorded by the Secretary and kept in the official records of the Corporation. Notice of Board meetings shall be given at least (10) ten days prior to the date of the meeting.

**4.1.2** Board members may meet via telephone conference call to discuss and transact business of the Board.

**4.1.3** Board members are expected to notify the Board Chairman if unable to attend a scheduled meeting because of illness, employment, or out of town travel. The reasons for absence will be recorded in minutes.

**4.1.4** A resigning Board member should submit a written resignation to the Board Chairman, with the effective date and reason for resignation. A Chairman of the Board who resigns should submit a letter of resignation to the Secretary of the Board.

**4.1.5** Membership of the Board shall be terminated after a member has missed two (2) consecutive meetings, or has missed a total of four (4) un-excused meetings in a twelve (12) month period.

**4.1.6** Any Board member may be removed from office for just cause by a two-third (2/3) majority vote of the members in good standing.

### **4.1.7 Officers - Duties of Officers.**

**4.1.8** The Chairman exercises the usual powers/duties customarily vested in the office.

**The Chairman:**

- Acts as an authorized representative of the corporation;
- Controls and coordinates Board Activity;
- Is the liaison between the Board and executive director; and
- Directs the preparation of the agenda.

**4.1.9** The **Vice - Chairman** performs the duties of the Chairman in his/her absence. When acting as Chairman, he/she has all the powers and restrictions of the office. The Vice-Chairman generally assists the Chairman, and performs such other duties that may be assigned by the Board.

**4.1.10** The **Secretary** preserves in the corporate books true minutes of the proceedings at all Board meetings.

**The Secretary:**

- Calls roll to ascertain a quorum for all Board meetings;
- Records and monitors attendance to determine continuous Board membership;
- Monitors Board correspondence and other documents of records;
- Assumes notices required by statutes, law or resolution; and
- Performs other duties as may be delegated by the Board.

**4.1.11** The **Treasurer** chairs the Finance Committee, serves as general consultant on financial matters of the Corporation and performs such other duties as may be delegated by the Board.

**4.1.12** The **Chief Executive Officer** or his/her designee will serve as and ex-officio member of all committees.

## **ARTICLE 5 - RESPONSIBILITIES OF COMMITTEES**

### **5.1 Responsibilities.**

The Board has final authority and responsibility for all aspects of the Corporation. Major areas of the responsibility are:

**5.1.1 Bylaws and Enforcement.** The Board shall determine the bylaws of the corporation and carry them out. The Board shall amend the bylaws when needed. The Board shall amend the bylaws with a two-third (2/3) vote of the voting membership.

**5.1.2 General Policies.** The Board shall establish all general policies, including personnel and fiscal policies, for the conduct of the program.

**5.1.3 Administrative.** The Board shall select and has the power to dismiss the Executive Director with a majority vote. The Board shall delegate to the Executive Director the authority to implement Board policies and supervise operations of the program.

**5.1.4 Financial.** The Board shall control major resources decisions and monitor financial viability through monthly reports of variance from revenue and expenditure projections. The Board shall approve the annual budget to assume adequate funds for facilities, equipment, staffing, and operational needs of the program. The Board shall insure that all requirements of funding agencies are met.

**5.1.5 Standing Committees.**

The responsibilities of the Board consist of related duties and functions. Standing Committees shall generally accomplish these duties and functions. Committees investigate, review, monitor and evaluate specific portions of the program and make recommendations to the Board for action. Committees may not take action for the full Board unless specifically empowered by the Board. All committees shall keep minutes of their meetings. Findings and recommendations shall be reported to the Board in writing and these reports shall become part of the Corporation records.

The Board chair appoints the chairperson and members of all committees for one (1) year terms. The chairperson of each committee may fill any vacancies that occur during the year.

**5.1.6 Executive Committee.**

This committee consists of the officers of the Board named in article 3.7. The executive director is a non-voting, ex-officio member. Three (3) Board members constitute a quorum for business. This committee meets as needed. The Chairman, executive director, or three (3) members of the committee may call meetings. The committee(s) duties are to:

- Advise or assist the Chairman in fulfilling his/her duties;
- Assist the Chairman to monitor compliance with applicable statues, laws, and regulations;

- Act for the Board as a whole in emergencies, when expedience demands and the Board cannot meet. Such action must be ratified by the Board at the next Board meeting; and
- Evaluate annually the performance of the executive director and recommend adjustment to his/her compensation to the full Board.

#### **5.1.7 Nominating Committee.**

The chairperson and committee members are appointed each year at the first meeting following the annual meeting. Only Board members may serve on this committee. No member can be on this committee at the time he/she is eligible for re-election. The committee consists of three (3) members and meets prior to the annual meeting and when a Board vacancy occurs.

The Committee's duties are:

- Prepare a slate of candidates for elections as set forth in Section 3.3; and
- Maintain a file of eligible candidates and nominate candidates for vacancies between annual elections.

#### **5.1.8 Finance Committee.**

The elected Treasurer chairs this committee. The Executive Director is the ex-officio member. This committee consists of three (3) members and meets prior to the regular meeting. The committee's duties are to:

- Review proposed annual budget and revisions prepared by administrations, and make recommendations to the Board;
- Review monthly financial reports for comparison with the budgeted revenue and expenses, and make recommendations;
- Evaluate the financial management and make recommendations;
- Review accounting system and procedures for compliance with financial policies and federal, state, and local requirements;
- Seek added income from donations and other sources; and
- Maintain written records of those proceeds to be available and include in all financial reports to the Board.

#### **5.1.9 Program Planning and Evaluation Committee.**

The Vice-Chairman shall chair this committee. The executive director is an ex-officio member. This committee consists of at least three (3) members and meets at least quarterly, but as often as needed. The committee's duties are to:

- Prepare annual grant application(s) in a timely fashion;
- Identify community needs and resources, and advise the Board regarding priorities, goals, and objectives;
- Recommend type and scope of service, hours of operations, staffing patterns, equipment, and facilities needed;
- Evaluate the current program and report to the Board on progress towards goals and objectives, and changes needed; and
- Monitor client satisfaction, utilization, and productivity

#### **5.1.10 Personnel Committee.**

This committee consists of three (3) members and meets at least quarterly, but as often as needed. The executive director is an ex-officio member. The committee's primary responsibility is to review personnel policies.

#### **5.1.11 Ad Hoc Committees.**

The chairperson and members of the Ad Hoc Committees are appointed by the Board Chairman to serve until the assigned task is completed. Committee members, as a group, should have the expertise to carry out the assigned task.

### **ARTICLE 6 - BOARD MEETING, MINUTES, AND REPORTS**

#### **6.1 Quorum for Business.**

A simple majority of the Board members in good standing shall constitute a quorum for conducting business. Ex-officio members are not considered in deciding a constitution quorum of the Board.

**6.1.1** Each Board member shall have one (1) vote. There shall be no proxy votes. Ex-officio members cannot vote.

**6.1.2** When expediency requires and the Board cannot meet, the Board Chairman may cause the issue to be presented and take each member's vote by phone call. This vote must be recorded and ratified at the next Board meeting.

**6.1.3** The Board may act only at a duly constituted Board meeting where there is a unanimous written consent of the Board.

**6.1.4** Board members should inform the Board Chairman or the executive director of items for the agenda at least ten (10) days before the meeting. The executive director will prepare the agenda as directed by the Chairman.

## **6.2 Annual Meeting.**

An annual meeting will be held each year in May, excluding its first year of operation. The Board will determine the time and place. Elections for Board members will take place at this meeting; the Board may determine other appropriate events.

## **6.3 Special Meetings.**

Special meetings may be called when deemed necessary by one-third (1/3) of the Board members. The Chairman and/or Secretary shall insure that a notice and statement of the purpose of the meeting be given to all members, including e-officio, ten (10) days prior to the meeting. The ten-day requirement for notice may be waived by a majority of the Board members but the requirement for quorum cannot be waived.

## **6.4 Minutes and Reports.**

All official proceedings, actions and resolutions of the Board shall be recorded in the minutes by the Secretary and preserved in the books of the Corporation. Performance evaluations, credential files, matters of litigation and other appropriate matters shall be considered as confidential and treated accordingly.

# **ARTICLE 7 - CORPORATE ASSETS, BOOKS, AND RECORDS**

## **7.1 Disposition of Income and Assets.**

All revenue and property received by the Board shall be devoted exclusively to carry out the purpose of the Corporation. No part of the revenue, income, net earnings, or property of the Corporation shall inure to the benefits of, or be distributed to its members, officers, or private persons, provided that the Corporation shall be authorized and empowered to any reasonable compensation for services rendered in the furtherance of the purpose for which it is organized.

### **7.1.1 Grant Funds and Donations.**

**7.1.2** All funds from federal, state and/or local governments shall be expended solely for the purpose for which they are granted, and according to all applicable federal, state and local laws and regulations.

**7.1.3** All donations and monetary contributions shall be used to carry out the general purpose for the corporation, unless the donation is for a specific purpose.

7.1.4 The books and records of the Corporation shall be set up and monitored by Certified Public Accountant in accord with all applicable federal, state and local laws and regulations. The books and records of the Corporation shall be maintained in the business office of the Corporation.


## ARTICLE 8 - DISSOLUTION OF CORPORATION


- 8.1 The duration of the Corporation is perpetual. However, in the event of dissolution, Louisiana law shall govern the Corporation. The Board may adopt a resolution recommending the Corporation is dissolved, and direct that it be submitted to a vote at a meeting of all voting members of the Corporation. Written notice, stating that the purpose of the meeting is to consider dissolving the Corporation, shall be given to each member entitled to vote, at least fourteen (14) days prior to such meeting. To be effective, the resolution to dissolve the Corporation must be adopted by at least two-thirds (2/3) of the votes cast at such meeting.
- 8.2 Upon the dissolution of the Corporation, the Board shall, after paying or making provision for the payment of all liabilities and following other requirements of Louisiana law, distribute remaining funds to charitable, scientific, literary or educational institutions. No part of the net earnings shall inure to the benefit of any private shareholder of the donee institution. The donee institution must be an entity of the type that qualifies for exemption under Section 501C(3) of the Internal Revenue Code of 1954 or corresponding future provisions of the federal tax law. Restricted funds or other assets from grants or subsidies shall be returned to the funding corporation or government agency.

## ARTICLE 9 - CONFLICT OF INTEREST

- 9.1 Board members, employees, consultants, and those who provide services or furnish goods to the Corporation are prohibited from engaging in any activity, which will result in a conflict of interest, or the appearance of impropriety.
