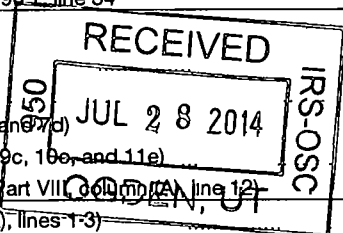

## 2013 Annual Report

### The Taylor Charitable Trust

Dear Fellow Trustees:

I am happy to report to you that in the past three years The Taylor Charitable Trust has completed three large (considering our modest size) milestone projects for the benefit of others and has initiated a fourth project funded solely by the TCT. One of these four addresses a primary purpose for which this Trust was created. I'll provide more detail about these projects in subsequent comments.

First, I would like to review our 2013 financial matters. We began the year with capital of \$2,663,693.17. At 12/31/13 our assets were 3,436,785.15. After disbursements of approximately \$150,000 and a capital contribution of \$300,000 from Marlene and me, we earned a net return of 24.16%. Through June 30, 2014, we earned a net return of 7.21%, ending with a balance of \$3,609,011.30 after year-to-date disbursements of \$72,500.00. Over our 17.5 years, the Trust has earned solid average returns, all the while underwriting worthy projects totaling \$1,746,922.96 in disbursements, nearly half of our current capital.

You may remember my long-standing complaint regarding the IRS position on short-term capital gains, which they regard as income, requiring 85% of any such gains to be distributed. This makes needed capital growth much more difficult, and it is unfair; no pensions or retirement (tax exempt) assets like 401-K and IRA accounts are treated this way. Capital is capital, short-term gains or long-term gains (or losses). Only interest and dividends are treated as income. Moreover, the IRS takes this position only through a so-called "Private Letter" ruling; the publicly printed official tax code of the Internal Revenue Service takes no such position. The "Private Letter" ruling is their (the IRS) "interpretation" of the tax code. Charities should challenge this position in court; they don't, because the legal fees would be prohibitive.

The three major completed projects of the last three years were Honor Village at Lakeshore Rehabilitation Hospital, to facilitate the long-term care often required for severely wounded soldiers and other handicapped persons and their families. The second project was the covered entrance project at Vestavia Hills Baptist Church, long-needed for our elderly and handicapped members and of general benefit to everyone in storm situations.

The third major project, and the centerpiece of our efforts to engender a wider appreciation of Maynard Adams' ideas, was the awarding of the Adams Prize in Philosophy (\$50,000) to Professor Michael Huemer of the University of Colorado at Boulder. Professor Huemer's paper was chosen by a blind pool of professional philosophers as the best paper on Adams' *Ethical Naturalism and the Modern World-View*. Dr. Huemer was already a distinguished scholar in ethics and it was a compliment to us that a person of his stature competed and won our recognition.

The fourth major project, now underway and almost complete, is a \$120,000 effort to renovate and re-landscape the rear entrance of Vestavia Hills Baptist Church. Expensive homes line the Smyer Circle entrance to VHBC; large steel garbage bins present our neighbors with unsightly views and occasional unpleasant odors. These renovations will restore our "good neighbor" status.

We are not averse to joining with others to support transformational projects, but all of the above have been underwritten by us where general budget funds were insufficient to address the need.

Finally, because of the untimely death of our fellow Trustee, Dr. Gillian Cell, we must elect a new Trustee. Dr. Max Owre, our long-time friend in the Program for the Humanities and Human Values at the University of North Carolina, is our nominee. Please give your assent on the enclosed ballot and return it to me in the enclosed envelope as soon as possible.

As always, Marlene and I extend our gratitude to you for your handmaiden service in the work we are able to do through The Taylor Charitable Trust.
