Consolidated 2013 data shows a total of 498,286 units of service provided by our United Way partners. Education 259,445, Health 320,586, Financial Stability 47,344, and Critical services 104,412. The organization also coordinates and serves on numerous task forces, including domestic violence, suicide prevention, education and youth committee, public transit authority, Metro Health, Drug and Alcohol prevention, and a non-profit Directors coalition.
