	As part of its overall mission, the Osteopathic Founders Foundation utilizes a significant portion of its resources on activities related to medical education Scholarships, which are granted competitively and based on academic achievement, professional ambassadorship, and community engagement, are provided to assist osteopathic medical students with the cost of their tuition, fees, and books Educational stipends, which are also granted competitively, are available to osteopathic residents enrolled in AOA or ACGME accredited postgraduate training programs, professional level employees of colleges of osteopathic medicine, or to professional level employees of a hospital which sponsors postgraduate training programs which are accredited by the American Osteopathic Association The Foundation's commitment to medical education reaches to the post-doctoral level through our programs of continuing medical education The CME mission of the Osteopathic Founders Foundation is to continually improve patient care by providing timely, relevant, evidence based clinical knowledge to osteopathic physicians and other healthcare providers In 2009 the Foundation received its initial accreditation from the American Osteopathic Association as a category 1-A provider That accreditation was renewed in 2013 In 2013, nine qualifying professional development programs were offered in diabetes, internal medicine, ultrasonography, pain management, and health policy and finance which trained over 400 health care professionals A partnership continued with the University of Oklahoma College of Pharmacy which allows our programs to qualify for continuing education for pharmacists as well as physicians In response to Oklahoma's crisis of prescription drug abuse, the Foundation presented six additional CME programs in five Oklahoma communities which trained nearly 200 osteopathic physicians in the proper prescribing of controlled dangerous drugs We are proud to say that our commitment to medical education serves the continuum from medical school through medical practice

	Community grants are an important part of the work of the Osteopathic Founders Foundation Since the sale of our hospital in 1996, the Foundation's trustees have focused on utilizing our resources in a manner consistent with the Founder’s original intent Grants are awarded to community organizations who share in our mission of providing care to the underserved and in the prevention and treatment of disease With a continually struggling economy, particular emphasis is given to the most basic needs of food safety and shelter Oklahoma's poor ratings for health of our citizens demands that many of our resources be directed to the provision of primary health services Just as an example, in 2013 the Mental Health Association in Tulsa received \$8,000 to support their residential programs HOPE, an agency which provides counseling, testing, and education on HIV and STI's was able to purchase a specially equipped van to travel to rural testing locations with the \$35,000 grant provided by the Foundation The Tulsa County Medical Society Foundation was supported with a \$15,000 grant to assist with their Tulsa Charitable Medical Services program which matches uninsured patients with volunteer physicians willing to donate services With a \$10,000 grant to Planned Parenthood of the Heartland, that agency was able to expand its primary care clinic which serves uninsured and underinsured patients in Tulsa A renewal grant of \$5,000 allowed the Iron Gate to continue its backpack program for children at risk of hunger, a problem exacerbated by increasing unemployment and economic uncertainty, and children of incarcerated parents received after-school mentoring because of a \$5,000 grant to New Hope Oklahoma

	About every 25 seconds, an American will suffer a coronary event, and about every minute someone will die from one Clearly, a public health issues, the Foundation has chosen to address the need for continued training of health professionals by establishing an emergency cardiovascular care training site accredited by the American Heart Association Training in advanced cardiovascular life support, pediatric advanced life support, and basic life support for healthcare providers is offered for physicians and other healthcare professionals The neonatal resuscitation program which is jointly accredited by the AHA and the American Academy of Pediatrics is also part of our suite of training services Nearly 700 professionals received certification in these disciplines through our site in 2013 Because only 31.4% of out-of-hospital cardiac arrests receive bystander CPR, we also place an emphasis on providing training in the basic skills of cardiopulmonary resuscitation to the lay community through the "Friends and Family" program Grants of \$9,500 were provided to the American Heart Association in support of women's heart health as part of our commitment to the treatment of cardiovascular disease

Reason for Public Charity Status under "Facts and Circumstances Test" as described in Temp. Reg. Sec. 1.179A-9T(f)(3)

Osteopathic Founders Foundation is recognized as an organization described in Code Sec 501(c)(3). It was created to support osteopathic medical education, to enhance the public's understanding of osteopathic medicine, and to improve the health of the community through projects consistent with the osteopathic philosophy.

Previously, as part of its exempt activities, the Foundation operated a hospital, which was sold in 1996. Because of the hospital operations, the Foundation received a significant amount of its support in the form of program service revenue, and was classified as a public charity because it normally received (1) more than 33 1/3% of its support from contributions, membership fees, and gross receipts from activities related to its exempt functions, and (2) no more than 33 1/3% of its support from gross investment income. Code Section 509(a)(2).

As a result of the sale of the hospital, the Foundation no longer receives the majority of its support from program service revenue. The organization did receive over \$2 million in 2006 and accrued an additional \$1.5 million in 2011 in Medicare fees from previous hospital activities. The 2011 accrual is the final settlement with Medicare. These two years' activities push the Code Section 509(a)(2) five-year public-support percentage in 2011 to 60.4%, up from 50.3% in 2010. Without this program service revenue, the Code Section 170(b)(1)(A)(iv) public-support percentage for 2012 is 18.81% from membership dues, public contributions, and fundraising contributions. The Foundation had accrued contingent liabilities related to prior hospital operations. Because of these liabilities, the funds from the proceeds of the sale were retained to offset those accrued liabilities. The obligation to retain funds was completed in 2010 and \$1.1 million of liabilities were eliminated. The cash retention to fund the contingent liabilities resulted in a five-year investment-income percentage of 38.7% in 2011 and 47.9% in 2010. Due to the sale of the hospital operation, which curtailed the Foundation's program service revenue; and the increased investment income due to the holding of funds to offset accrued liabilities, the Foundation did not meet the Code Section 509(a)(2) public-support test for its current or prior tax year. The organization can continue to qualify as a public charity because it receives a substantial part of its support from the general public described in Code Section 170(b)(1)(A)(iv). The public-support percentage exceeds 10%, and the Foundation conducts the following activities to attract public support:

1. Annual fundraising event "Winterset" a gala event featuring music, entertainment, dinner and awards. Proceeds are dedicated to the support of scholarship programs and community grants.
2. Membership dues from Foundation members, both annual dues and lifetime dues are solicited.
3. Contributions are solicited through the membership, during the fundraising event, and through personal contact for the support of the Foundation's charitable programs (scholarships, educational programs, community grants, and the ECC training center).

- 4 Tuition is charged for the accredited programs of the ECC training center

The Foundation has continued the following activities related to its exempt purpose:

- 1 Scholarships to assist osteopathic medical students
- 2 Educational stipends to assist resident physicians in post-graduate training programs
- 3 Presentation of a program for 2nd and 3rd year medical students to prepare them for the residency “match”
- 4 Operation of an AHA accredited Emergency Cardiovascular Care (ECC) training center In 2013, six hundred sixty five (665) physicians and other healthcare providers were certified in Basic Life Support (BLS), Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), and Neonatal Resuscitation (NRP)
- 5 Presentation of six seminars on the Proper Prescribing of Controlled Dangerous Substances in 4 Oklahoma communities One hundred eighty three physicians (183) were trained
- 6 Creation and presentation of nine continuing medical education (CME) seminars accredited for osteopathic physicians and pharmacists Four hundred six (406) healthcare professionals received education in current clinical topics
- 7 Creation and presentation of the Community Osteopathic Outreach Program providing free seminars on health related topics to the lay person Programs were presented on nutrition and on back and neck pain in 2013 Quarterly “Senior CPR” was offered to elders in the Tulsa area

Base on the ongoing efforts to attract public support; the activities conducted in keeping with its exempt purpose; meeting the 10%-of-support test; and because the Foundation plans to devote more of its assets to charitable expenses in the future (which will reduce the amount of investment income), the organization meets the “facts and circumstances test” and is classified as publicly supported for the current tax year
