This included constructing and equipping a children's area, a youth facility, a dining hall and a full-service kitchen. Funds were also provided to assist with a new roof for one of the buildings. The church has 300+ regular attendants and serves many hundreds more in the area with various outreach activities.

Provided funds for the support of religious higher education, including:
(1) Funding for Malawi Assemblies of God (A/G) School of Theology ongoing construction, maintenance, & student scholarships in Lilongwe, Malawi. The school trains approximately 240 ministers, religious education workers, & children's workers per term. These will pastor and do church work throughout Africa;
(2) Funding to write a college-level Bible course called "Man & Sin, Christ & Salvation" that will be used in 900 Spanish A/G Bible Schools in Latin American and to help train 3 million house pastors in Northern Asia.

Provided funds to assist with ministry endeavors in foreign lands, including:
(1) construction of Assemblies of God (A/G) church buildings in Africa --1 in Monrovia, Liberia, and 1 in Maputo, Mozambique. Each of these steel structures can accommodate 350 congregants; (2) remodeling the Springfield, MO headquarters of Africa's Hope and several other ministries serving the 50+ countries of Africa where the A/G has more than 65,000 churches and 16 million believers;
