Explanation of the amount in Part XI, line 9 - The income appearing to be \$8,838 more than the expenses is a result of several factors as listed below:

A vehicle was donated in December with a current market value of \$4,077. The 990 instructions require the value on this donated vehicle be included in the total income for the year, causing the income to appear higher than it actually was. There were also "Decrease in Income" entries in 2013 totaling \$1,680 which resulted in the total income for the year to appear higher than it actually was. These entries were due to PayPal fees that were held out of on-line credit card donations that never were deposited into the BBI bank acct. The full amount was shown in the total income for 2013 so donors could be receipted for the total amount of their contributions. The rest of these "Decrease in Income" entries were due to refunds and reimbursements.

There were also "Decrease in Expense" entries in 2013 which reduced the total expenses in 2013 in the amount of \$2,475. These were Rebates on purchase of equipment, Refunds and Reimbursements.

There was also a fund adjustment of \$606 which was to synch the total funds to agree with the actual bank account balance.

This \$4,077, \$1,680, \$2,475 and \$606 total \$8,838 which accounts for the income reflecting \$8,838 higher than the expenses on the

Reconciliation of Net Assets Part XI section.
