In 2013, two major disbursements of funds were made at the request of the Lincoln Center with regard to major/minor renovations:

\$23,125.41 was paid to the Architect/Contractor (via the Lincoln Center) for final change orders and additional services. Both contracts have now been closed.\$56,092.12 was paid to Facilities Operations, City of Fort Collins for work completed in the Columbine Room at the Lincoln Center. Renovations were not included in the original scope of work due to cost cost over-runs on the original project. After closing out the final contracts, additional funds were available and were used for HVAC, lighting, carpeting, and painting. Scope does meet the original intent of the Capital Construction Campaign.Funds continue to be received as donations for the Capital Construction Campaign. Donations are received and are deposited into a savings account and dispersed upon request of the Facilities Manager of the Lincoln Center.**4b** (Code:) (Expenses \$ 3,891.70 including grants of \$) (Revenue \$ 10,751.00)Hall of Gifts - Annual artisan/crafter fair held each year at the Lincoln Center. This is the biggest fundraising event for the Lincoln Center Support League (LCSL). Approximately 40-50 vendors are represented each year. Vendors do pay a fee for a specific "booth" area within two conference rooms at the Lincoln Center. An entrance fee of \$3.00 is charged for the three-day event.**4c** (Code:) (Expenses \$ 2,194.82 including grants of \$) (Revenue \$ \$3,045.00)Gallery of Trees - a holiday display of decorated holiday trees by local business owners. Additionally, small 3 ft. trees are provided to local artists/crafters/community members to decorate. The 3 ft. trees are part of a "silent auction" that is used to bring in additional funds. (3) An Ice Cream Social is held every year as a "thank you" to the staff of the Lincoln Center. (4) A Children's Summer Series is offered for five weeks during the summer that provides local performances geared to young children. There is no cost to attend. (5) During the holiday season the trees outside the Lincoln Center are "lit up". A special contract with a local lighting/landscape company provides this special event.

Part IX - 24 c -- other costs include expenses for Gifts of Warmth, Trees and Treats, Ice Cream Social, Children's Series and lighting project.

There is no revenue associated with any of these projects.

Part IX - 24 d - This year there were two disbursements from the "fundraising" account at the request of the Lincoln Center. Costs were for closing out the contract with the architect/contractor due to change orders and final costs. The other expenses were paid to the City of Fort Collins Facilities Operations to cover remodeling of the Columbine Room (e.g. HVAC, electrical, ceiling grid, etc.)

Part XI - #3 This is a deficit this year due to expenditures above revenue with regard to the Capital Campaign (fundraising). In 2013, there were two debits against funds (as described in Part III, Section 4a). These expenditures were covered with available funds received during the previous remodel/renovation campaign. Funds have been maintained in a separate savings account. Remaining funds in the account are allocated to the Support League to cover administrative costs/operating costs. The campaign is now very "low key" although additional funds are being received each year. Additional funds are still maintained in the special account and will be used by the Lincoln Center for only remodeling/renovations at the Lincoln Center.
