 The organization funds and supports neurofibromatosis research projects and participates in a Neurofibromatosis National Affairs Coalition to increase public awareness and insure and increase funding allocated from federally funded programs.

4b (Code) (Expenses \$ 80,106 including grants of \$ 4,000) (Revenue \$)
 The organization provides neurofibromatosis educational materials/information to patients, physicians, teachers and counselors; physician and clinical referrals; and statewide neurofibromatosis clinics. It conducts an annual symposium featuring nationally recognized researchers, a yearly family camp, and family support groups. In 2013, the symposium was held at Children's Medical Center and serviced 54 patients, the family camp served 114 patients and family members, and 9 support groups were held serving 131 patients.
