Therapy/Counseling Services provides individual and group therapy/counseling to adult victim/survivors of domestic violence Three support groups are held weekly, including one group for adult English-speaking victims, one group for adult Spanish-speaking victims, and one group for battered women detained at Hilltop House Detention Facility Individual therapy and counseling is provided as needed or requested The Alternative Horizons therapist is available on a weekly basis at the Volunteers of America Southwest Safehouse to provide counseling to residents The program also provides individual and group therapy/counseling to youth and children who have either witnessed domestic violence in their homes or have been victimized by dating violence A weekly counseling group is held at DeNeir Youth Services Center, a detention facility for youth During 2013, 80 survivors and 67 youth, and 53 multicultural survivors received therapy and counseling from Alternative Horizons
