Additionally, the staff reviews current programs and new requests to ascertain how best to distribute services statewide to achieve optimal services throughout the state. The staff makes recommendations to the TAJF Board. The Board conducts interviews of new applicants to obtain any additional information they need. The Board votes on each grant application by region. Finally, the TAJF Board submits its recommendations to the Texas Supreme Court for their review and approval. An applicant does not become a guarantee until the Court signs the Order approving the TAJF Board's recommendations
